Little, Shapiro Win NAAC Competition

John Little and Ron Shapiro, thirdyear students at the College, won the National Appellate Advocacy Competition (NAAC) held in New Orleans, August 6-9. The competition, sponsored by the Law Student Division of the American Bar Association, pitted the FSU team against 18 other regional winners.

Little and Shapiro were the only undefeated team in the competition, which involved a public sector labor problem. They also took the prize for best brief.

Coached by Professor Patricia Dore, the FSU team beat Harvard in the semi-finals and Illinois Institute of Technology Chicago-Kent in the finals. Professor Dore also coached the team that won the national championship in San Francisco last summer. It

Mason Ladd Memorial Lecture Series, October 15-16

The College of Law is happy to announce the creation of the Mason Memorial Lecture Created to memorialize the first Dean of this College, public lectures will be scheduled annually and will address those subjects especially important to Dean Ladd: Evidence, Civil Procedure, The Legal Profession, and Legal Education. The College will cause to be produced in hard bound copy the text of the lectures. Royalties from the sale of these books plus private contributions will be used to fund the lecture series.

Professor Ronald Carlson of the Washington University School of Law, co-author with Dean Ladd of Cases and Materials on Evidence, will be the first lecturer in the series. Professor Carlson, a distinguished professor, is the author of four books and numerous professional articles. He has taught at the University of Texas, the University of Iowa and Wayne State University. Trial judges and trial practitioners know Professor Carlson as one of the lively and informative Evidence lecturers at CLE programs.

The lectures will be open to the public, and special invitations will be extended to the graduates of the three classes admitted by Dean Ladd: 1969, 1970 and 1971. This year's lectures are scheduled for October 15 and 16. In addition, a Reunion Banquet will be held on Saturday, October 17 at which Professors Carlson, Ehrhardt and others will reminisce about Dean Ladd.

college Receives \$4,326,000 Appropriation from '81 Legislature for Library Addition

During the 1981 Session of the egislature, the College received an ppropriation of \$4,326,000 for Law ibrary construction and remodeling. This sum, added to the \$674,000 appropriated by the 1980 Session of the egislature, gives us the opportunity o add a much needed Library Addiion to the College of Law. The firm of Sheppard and Associates of Jackonville, Florida has presented to the University and the College's Building Space Committee advanced and schematics for the three-floor Library Addition. The design contemplates joining the new addition and B. K. Roberts Hall at the second-floor and third-floor levels. The net square footage will permit us to double the current hard bound volume collection. At a subsequent time, drawings and pictures will be furnished you so that you can share in the excitement.

In his open letter to the Alumni, the Dean gives special thanks to those alumni who are members of the Legislature, and who worked with the College to secure the Legislative appropriation. The matter is important enough to say again: special thanks to Senator Kenneth C. Jenne and Representatives Peter M. Dunbar, S. Curtis Kiser, Christian Medford, George H. Sheldon and James Harold Thompson. Representative Herbert F. Morgan of Tallahassee was, also, significantly supportive.

is extremely rare that one coach has been involved in a national championship for two consecutive years.

One hundred twenty-four teams across the country began the competition in March and April 1981 when the regionals were held. The FSU team was 1 of the 19 teams which were chosen to advance to the na-

tionals in New Orleans. Briefs, written after the regionals, were submitted to a panel of appellate court judges and experts in the labor field who were selected by the NAAC Committee.

She attended the Brussels Seminar on the Law of the European Communities and the Hague Academy of International Law, as well as the ABA Institute on Current International Legal Aspects of Licensing and Intellectual Property. She is currently a member of the Bars of Georgia and Massachusetts.

Professor Christie will be teaching Commercial Law (Sales and Notes) in the Fall Semester; Commercial Law (Secured Transactions) and Coastal Zone Management Seminar in the Spring.

Assistant Professor Nat S. Stern

Nat S. Stern has been appointed Assistant Professor. He joins the College of Law faculty from Arnall, Golden & Gregory in Atlanta where he has been practicing Corporate Law since 1979.

Professor Stern has his A.B. from Brown University and his J.D. from Harvard. The College's word processor was recently updated to Exxon's most advanced model, the Vydec 1800 text editor, which includes program diskettes for records procesdocument assembly, global search and replace, and many other features to economize time and cost in the production cycle. In addition, the telecommunication / computer batch interface setup has been successfully tested with both Exxon corporate headquarters and Darby Printing Company.

In April 1981, the Review's editorial assistant, Debbie Winter, traveled to Darby Printing Company in Atlanta for training in the computer coding system necessary to transmit copy compatible and ready for the printer's

computer typesetter. The Review will be the first of over 104 law reviews printed by Darby to use telecommunications to transmit copy. Both Darby and the Review are enthusiastic about this innovation and anticipate success.

In preparation for converting to the new transmission mode, the Review has scrutinized and revamped the production cycle to best take advantage of the new technology, yet maintain the integrity of the editorial process. The staff manual has also been revised considerably to reflect these improvements and new information. The membership has undergone training to prepare them for the new system.

The first issue to be generated using telecommunications will be 9:3, projected to be available October 1981. The Review looks forward to the cost and time reductions the new system will provide.
