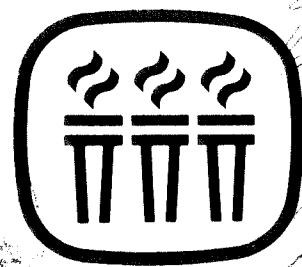

Law Library Groundbreaking Ceremony Held February 24

Groundbreaking ceremonies to celebrate the beginning of construction of a \$3.4 million, three-story addition to the College of Law Library were held February 24. The new library, which will have more than double the shelf and carrel space of the current library, is now under construction by Dyson and Company of Pensacola and is scheduled for completion in July 1983.

Almost every seat in the new library will be adjacent to computer conduits. Conference rooms in the new building will be able to receive video signals from a central playback site within the library. The new facility also is designed to allow the addition of a fourth floor when additional space is needed.

Since 1971 when the law building was first occupied, the library collection has grown from 39,000 volumes to more than 213,000. This growth

moved the law library nationally from 132nd to 46th.

Included in the project are renovations to various areas of the school. The current student lounge will be converted into a 30-person conference room with additional offices for assistant deans, admissions, registrar and records. The second floor of the current library will be converted into student and staff lounges complete with lockers. The renovations are scheduled for completion by October 1983.

Speakers at the February 24 groundbreaking ceremony included Florida State University President Dr. Bernard Sliger, College of Law Dean L. Orin Slagle, Florida Supreme Court Chief Justice Alan Sundberg, Florida Representative James Harold Thompson, Retired Florida Supreme Court Chief Justice B. K. Roberts and Law Librarian Edwin Schroeder.

Fall Interviews Begin September 13

As the first official day of Fall Interviews approaches, the Placement Office and the 2nd- and 3rd-year students are anticipating a very busy semester. The Placement Office has been reserving interview dates since early April. As of May 14, over 50 prospective employers have sent in confirmations for the Interviewing Season which begins Monday, September 13.

In July, all 2nd- and 3rd-year students will receive the Placement Information Packet. The Packet will serve not only as an introduction to the services offered by the Placement Office, but also will inform the students of what the on-campus interviews will entail on their part: writing resumes and cover letters, attending the Interviewing Workshop, self-evaluation in their job hunting program, etc.

Among the firms scheduled to visit the law school are four Atlanta firms: Lamon, Elrod & Harkleroad; Jones, Bird & Howell; Smith Currie & Hancock; and Altman, Kritzer & Levick. Also from out of state are the firms Squire, Sanders & Dempsey of Cleveland, Ohio and Hodgson, Russ, Andrews, Woods & Goodyear of Buffalo, New York. The Placement Office is especially pleased to have Shell Oil Company and the Tennessee Valley Authority returning to interview this Fall. Southern Bell out of Atlanta will be interviewing this Fall as well.

Interview dates are yet available for October and November. The College of Law Placement program is growing, but it needs the support of its alumni.

Scoring Scale, Test Change In LSAT

Beginning with the June 1982 administration, the Law School Admissions Test (LSAT) will have been significantly changed. The sections themselves have changed: the quantitative portion has been deleted; writing ability will no longer be scored;

and the time allotted to each of the six sections has been changed to 35 minutes each. The scoring scale has changed as well. Instead of the former scale of 200-800, the new scale will range from 10-50. The median score on the former LSAT was approximately 500; the median score on the new is predicted to be 30. Those applicants who took the test in June will provide the baseline data—we will have to wait and see how the scores fit into the new scale. We predict that the average score for the 1983 entering class will be above 35.

There are several reasons for adopting a new test and a new scoring scale. The new scale should give a better indication of ability by eliminating minor differences in scores. Currently, a score of 600 appears to be significantly "better" than a score of 590, but, in fact, the difference is not statistically significant. New scores will more accurately place applicants along the scoring scale. The new test will provide a writing sample from each applicant produced under uniform testing conditions.

The 1983 admissions year will present challenges for all of us as we

adjust to the new test. Undergraduate grade point averages may be relied upon somewhat more heavily than in the past, as will percentile rankings of the applicants. The new Index number (a composite of the LSAT score and GPA) will also be very different. Instead of being expressed in four digits (e.g. 1125), the Index will now be a two-digit number (with 14 being the highest number possible).

Many of you will be writing letters of recommendation for 1983 applicants and will need to be familiar with the changes from Law School Admissions Services. If you have questions (and all of us will), call Lynn Holschuh or Theresa Miller in the Admissions & Records Office (644-3288) and they will help you.

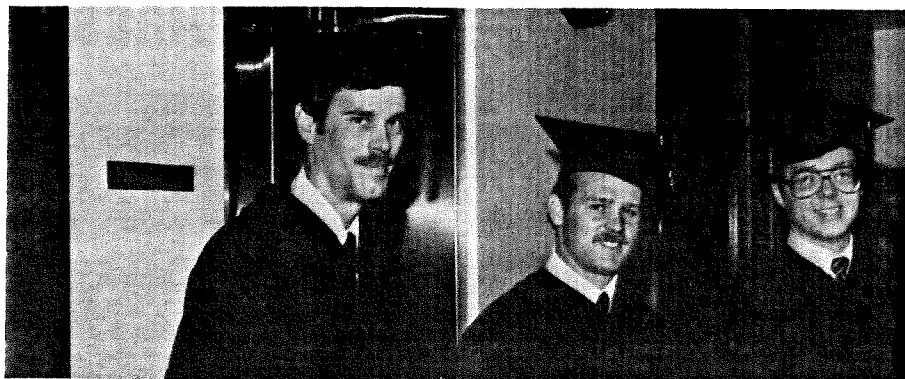

Public Service

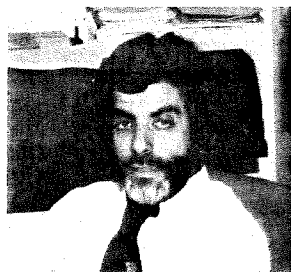

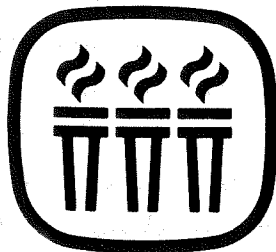
'82 YLS Job Fair Exceeding Expectations

The 1982 Young Lawyers Section Job Fair held on Saturday, February 13 at the Tampa Marriott Hotel drew 35 law firms, public agencies and private businesses all interested in conducting interviews of prospective law school graduates. At least 150 law students from Florida State University, Stetson University, Nova University and the University of Florida participated.

"The participation in this program far exceeded our wildest expectations," said Committee Chairman Ed Krieger, as he announced statistical results at the YLS Board of Governors meeting at Grenelefe on April 15. Krieger, a June 1977 graduate of the College of Law, went on to say that the program was a huge success from both the standpoint of the interviewing law firms and the law students. It was his desire that the program be continued and expanded in the coming year.

The interviews took place on February 13. The job interviewers conducted 20-minute interviews from 9 a.m. to 5 p.m. with a lunch break. Some of the interviewers had such a full schedule that they were unable to stop for lunch. Many suggested that the Job Fair next year be expanded to two full days. There were also suggestions that the interviews be expanded to 30 minutes each with a break in between.

After the Job Fair was concluded, the most common suggestion received from law students concerned acquiring additional information about the individual firms interviewing. The students would have liked to have seen a resume of each law firm, public agency and private business prior to interviewing with them. They felt this would have aided them in selecting interviews.

Moot Court Teams Win Nat'l Admin. Law, S. Division of Patent Law Competitions

The Florida State University College of Law Moot Court Team had an extremely successful and competitive 1981-1982 academic year.

One team won first place honors in the National Administrative Law Moot Court Competition held March 26-27, 1982, in Dayton, Ohio. The championship team members were Kevin Monahan, Andrew Rock and Paul Jess. The team, coached by Professor Nat Stern, was successful in all six rounds of the competition and defeated Southwestern University School of Law, Los Angeles, California, in the final argument. More than 18 law schools were represented. This year the Howard Leventhal Trophy was brought to Tallahassee where it was presented to Dean Orin Slagle.

Prior to this victory, another team won the Southern Division of the Giles Sutherland Rich Patent Law Moot Court Competition held March 16-18 in Houston, Texas. The team members, Al Frith and Doug Spears, subsequently went on to win the National Final which was held in Washington, D.C. Sponsored by the American Patent Law Association, the competition involved more than 28 law schools nationally.

As winners of the ABA-LSD National Moot Court Competition in 1980 and 1981, the Florida State University College of Law Moot Court Program is developing a national reputation for quality and excellence in oral advocacy.

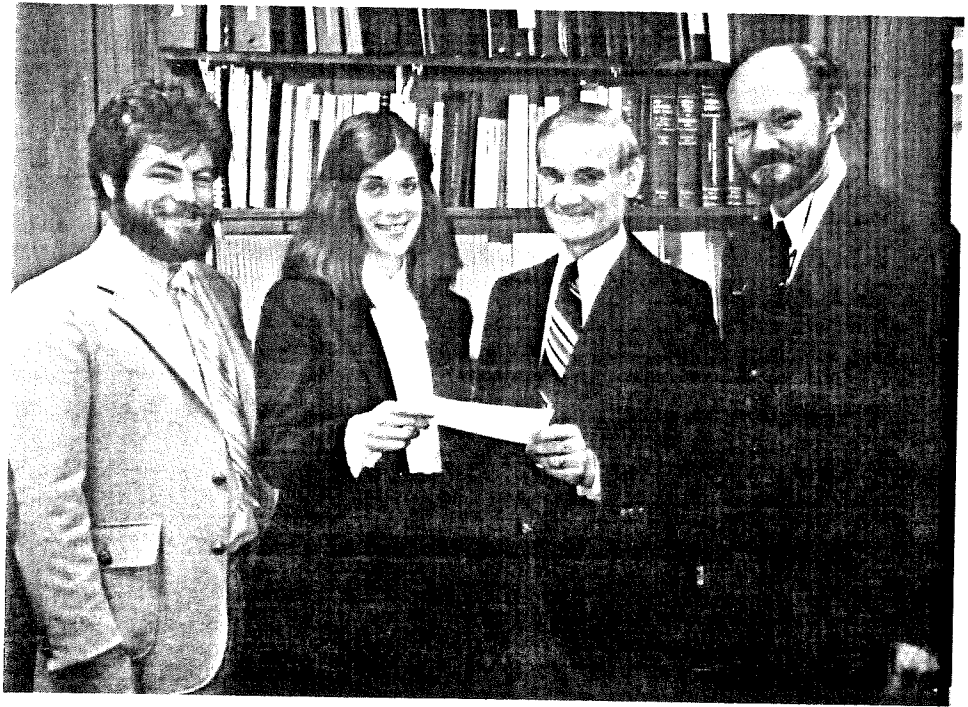

Ms. Townes is executive editor of the Law Review and was a junior high school English teacher in Sarasota prior to coming to the Florida State University College of Law.



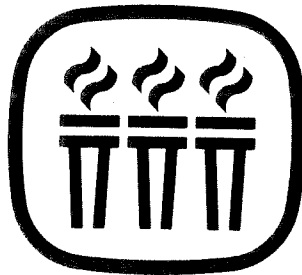
