From the Dean

Another academic year and another anniversary of my term as Dean have passed. Though it might appear immodest for me to say so, I think that it was one "helluva" year. It is not immodest for me to say so. The accomplishments that I want to report are not mine, but ours! They are accomplishments of the Faculty, Students, Alumni and University and Legislative leaders.

At this writing, the Law Library Building is very near completion and the renovation of B. K. Roberts Hall is speeding toward completion. In early June, Library personnel and collection were moved into the second and third floors of the new building so that the renovation could commence. *The new Law Library is simply beautiful.* It is spacious and accommodating. In the language of the day, "it is user friendly." Please come and see for yourself. You will share our pride in what must be one of the best designed legal research facilities on any University campus. If you agree, please also make a point of telling the Library Staff, especially Ed Schroeder. Ed has devoted his every effort, for at least the past eighteen months, to the planning and oversight of the project. The building evidences the work of many able persons, but none more able than Ed Schroeder.

Contained in the 1983 Legislative Appropriations Bill is the first installment of the Law School Enhancement Program. The objective of this program is to allow the two State-assisted Law Schools to rise to the very top of all Law Schools in the Nation. In the Appropriations Bill are five hundred thousand new dollars

From the Board

Help. The first major Alumni fundraising project needs your contribution.

On October 24, 1981, John J. ("Bud") Daley, Jr., a member of the Charter Law School Class, was killed in a plane crash in Gainesville, Florida. Bud had an outstanding career in the practice of law, even though it was for a very short period of time.

After his graduation from FSU, he clerked for Judge Bryan Simpson of the Fifth United States Circuit Court of Appeals. Bud left the clerkship and went to graduate school at the University of Georgia, receiving an LL.M. with honors in jurisprudence. After graduation, he went to work for the United States Attorney's Office in the Middle District of Florida, where

he had an outstanding record. He became the Chief Assistant in 1975. In 1978, he was Court appointed as the Interim United States Attorney for the Middle District of Florida and served until 1979. He was one of the three finalists for the United States Attorney position for the Middle District. After leaving government employment, Bud went to work for the law firm of Corrigan & Moore. He left Corrigan & Moore and went to work for the law firm of Holland & Knight, in Bartow, where he was employed at the time of the fatal accident.

Bud was truly a lawyer's lawyer. He participated in some significant trials for the United States as Chief Counsel. Bud was not only an outstanding lawyer, but his ability and reputation were a fine example for others of the caliber of graduates of the FSU College of Law.

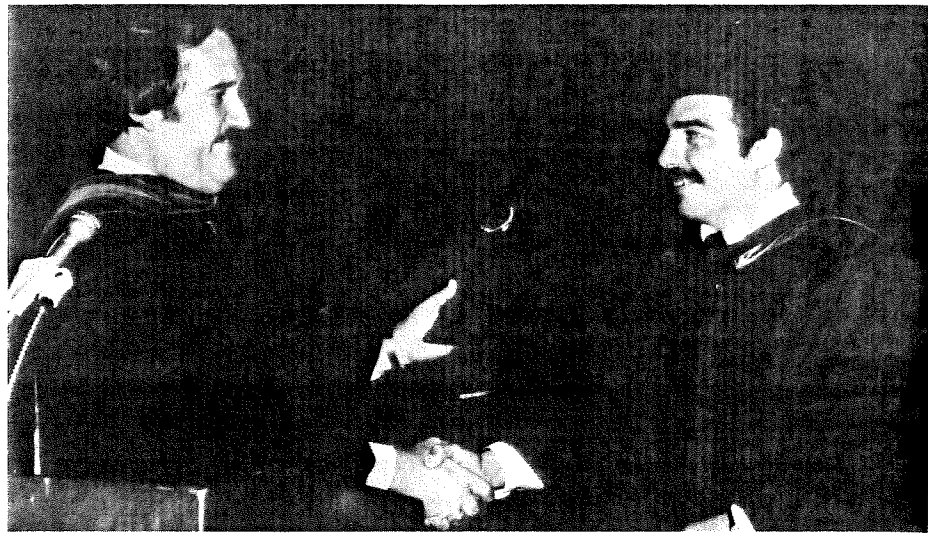

First Alumni Association Student Service Award Presented to Lombardo

James Christopher Lombardo, an April graduate of the Florida State University College of Law, was the recipient of the first annual College of Law Alumni Association Student Service Award. John W. Frost, II, President of the College of Law Alumni Association, presented an engraved plaque during Commencement Exercises on April 30, 1983, in Ruby Diamond Auditorum. The Student Service Award was established by the Alumni Association to recognize a third year student who has made a significant contribution to the students of the College of Law and to the College, through service within the College of Law or service outside the College which reflects positive credit upon the College of Law and the Florida State University.

Mr. Lombardo, a native of Orlando, Florida, was nominated for

the award on the basis of his extensive service in many areas. He rendered exceptional service to the College of Law in conjunction with Law Day activities for the past three years, in connection with the preparation of the College of Law catalog and in assistance to the Environmental Law Society. He was active in the Student Bar Association and was a member of the Law Review. He coached the College women's intramural football team to an undefeated season. Chris served the University by assisting the Union Program Office Council and the community by his involvement in Boy Scout activities. In addition to his service, Chris was highly recommended by faculty and peers for his warm kindness and sense of humor, which have contributed greatly to the law school environment.

Visiting Professors Teach During Spring Semester

The College of Law curriculum was enriched during the Spring Semester through the teaching of two visiting professors. Professor Alfred F. Conard, Henry M. Butzel Professor of Law from University of Michigan Law School and author of *Enterprise Organization and Corporations in Perspective*, taught courses in Securities

Regulation and Corporate Finance. Two sections of Trial Practice and Litigation Seminar were taught by Kenneth L. Connor, a noted trial attorney from Lake Wales and a 1971 graduate of the College of Law. Comments from students enrolled in these courses indicated that the professors were enthusiastically received.

New Law Library Open; Roberts Hall Renovations Continue

On Thursday, June 9, the Law Library staff completed their move from the library space in B. K. Roberts Hall to the new library addition. On that date, the second and third floors of the new Law Library facility were opened to the public.

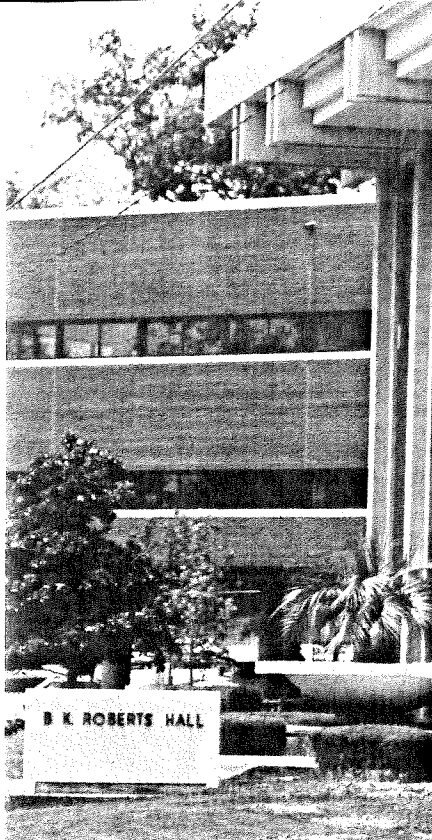
Although some equipment had not arrived, all essential functions became operational in the new building on June 9th. The third floor collections and equipment were completely in place. The second floor lacked some equipment, but staff members had occupied their new offices. It was expected that the building would be completed and fully equipped by August.

Renovation of B. K. Roberts Hall began in May. The clouds of dust and sounds of construction indicate that progress is being made toward expanded office space, a new student lounge, and a larger courtroom. Most of the renovated areas will be occupied by the beginning of the Fall Semester in late August.

The improvement of the law school's physical facility is exciting and indicative of great things to come. Alumni are invited to visit at any time to tour the building and view the progress of the College of Law.

Board's Five-Year Plan Envisions Stronger Alumni-Law School Ties

At the Board of Directors meeting held during the Florida Bar Convention in June, Ken Connor announced the details of the Five-Year Plan to be implemented by the Alumni Association. The programs summarized in the Five-Year Plan are designed to create stronger ties between the alumni and the College of Law. The programs included in the Five-Year Plan are listed below in their entirety. Some of these programs are already being implemented. For example, the Mentor Program will begin this Fall, and alumni in several areas are establishing local alumni chapters.

Local Chapters - College of Law Alumni Association

Several alumni have expressed interest in forming a local chapter of the FSU College of Law Alumni Association. The development of

strong local chapters should be encouraged since they would provide a local focal point for alumni. Local chapters could sponsor social events designed to encourage fellowship and comraderie among local alumni and could be a vehicle for generating local financial support for the law school. They could also be used to host dean or faculty visits and local chapters could be of great value to the students as an aid in local placement. Depending on the demographics, local chapters could be organized on a city, county, or circuit basis. We need to determine the number of chapters we want to establish within the next five years and identify the alumni who can provide the necessary leadership to ensure an effective functioning local chapter. We also need to determine the organizational vehicle which would be used to form the local chapters (i.e., tax exempt corporations, etc.) and provide forms (proposed bylaws, incorporation papers, etc.) to aid in setting up the organization.

with which we can increase the number of Faculty members; improve support services; improve the Library collection and plan new programs. (While it was intended that some portion of the money could be used to improve the competitiveness of our Faculty salaries, the general prohibition against salary increases for State employees denies us that opportunity during 1983-84.) In the last issue of this Newsletter, there was a report of Representative James Harold Thompson's commitment to improving the quality of higher education and, especially, to improving the quality of Legal Education. That vision, wisdom and commitment are clearly seen in the Law School Enhancement Program. The Legislature is making the resources required for greatness available to us. If we do not achieve greatness, it will not be because the Legislature denied us the opportunity.

Yet another Legislative action permits us to address a significant problem. Senator Carrie P. Meek sponsored a Bill which provides us with ten fellowships for minority students. Each fellowship carries a stipend of five thousand dollars. The fellows are to be denominated Virgil Hawkins Fellows. Increasing the enrollment of minority students in the College is a must. The support that this appropriation allows presents us with that opportunity.

On April 29 in Tampa, the Kurt Waldheim Appreciation Dinner was held. The proceeds from that Dinner were committed to the Kurt Waldheim Eminent Scholar Chair for Florida State University's College of Law. The significance of the event was captured by Senator Edmund Muskie in his keynote address. He said,

"So, what you begin now in Florida by endowing a chair for International Law at Florida State, is a perceptive—indeed, essential step—in broadening the foundations on which to build a world at peace with itself."

"By endowing a chair at a great University, Floridians are making the enlightened point that the roadway to peace must pass through the halls of learning.

You can pass on great lessons to all who come here. And the first of those is that peace cannot be found at the bottom of a National purse exhausted by military spending. In a world that commits hundreds of billions each year to the weapons of war, it is not much to ask that we pledge thousands to the hope of peace.

I come here today not as a fundraiser, but as one who would dare raise the standard from the issue of how divided people can *fight*, to how sincere people can *unite* in the search for peace."

Alumnus Rick Rumrell was the organizer and planner of the Dinner. Contributions to the Fund are still being received. It is important to us to see that the full six hundred thousand dollars is raised so that we might have the four hundred thousand pledged by the State. With Rick's help, we will continue to try to fund the Chair.

Your President, John Frost, introduced a new theme for the Alumni. That theme is "Get Involved." It has happened. The Reunion was well attended and the attendance at the 1983 Reunion will be even greater. More people came to the Reception at the Bar Meeting than have ever attended before. During my visits around the State, I sensed an enthusiasm, excitement and interest in the affairs of the College that did not exist during my earlier visits. Alumni are involved. If you are not, why not? It is axiomatic that the relationship of the College and the Alumni is symbiotic. Our successes are yours; your successes

are ours. John Frost has been and is a terrific President. He, personally, has undertaken to raise the money required to furnish the Bud Daley Memorial Student Lounge. He has spent countless hours in his efforts to stimulate Alumni interest and support. Selfishly, I can say that the time has been well spent. In time, you too will be saying that his efforts were importantly directed.

Your fellow alumnus Ken Connor spent a very successful four months with the College as an Adjunct Professor. Faculty and students were greatly impressed with his pedagogical skills. Equally important, we were all impressed with how proud he is of his Law School alma mater. In addition to the tremendous teaching that he did for us, Ken made a very substantial financial contribution (the largest that the College has ever received from one of its alumni) to commence the Alumni Scholarship Fund. This fund will allow us to reward student scholarship and allow us to let the students know that the alumni care.

During the year, there were many other involved persons, events and occurrences. Some of them are noted or reported elsewhere in this Newsletter. Space limitations deny me the opportunity to speak to them. Nevertheless they and the matters I have addressed made 1982-83 one "hulluva" year for Florida State's College of Law. For the Faculty and for myself, THANKS to all who were involved!

College to Issue New Diplomas

Lynn Holschuh, Director of Admissions and Records, has indicated that diplomas for the April 1983 graduating class are expected to arrive in approximately 60 days. Replacement diplomas for graduates from August 1980 through December 1982 will be included with the shipment. These diplomas will be the 12 x 16 size desired by graduates for more suitable framing.

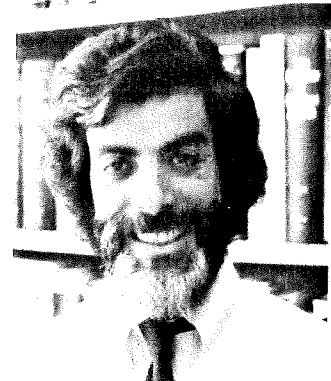

Dean Trips

Dean Slagle has made several trips around the state to visit alumni. Attendance at these meetings has often been small; however, they have always led to increased good will for the law school. Hopefully, the meetings will have a snowball effect. These trips should continue and, in the future, may very well be organized by the local chapter of the Alumni Association. Additional promotion for the trips (i.e., letter from the Dean, chapter president, etc.) needs to be encouraged in order to maximize the benefits from these trips.

CLE Seminars for Alumni

The law school is in a unique position to sponsor educational programs for alumni. Serious consideration should be given by the College of Law and the Alumni Association to sponsoring seminars which would attract the alumni back to the law school. The Annual Alumni Lectures, which were inaugurated last year, are a good first step. Additional programs should be considered. The University of Florida College of Law is sponsoring an evidence seminar soon in Tampa. Our law school should consider a similar program. The law school and the Alumni Association should consider co-sponsoring seminars with private seminar companies. Private seminar companies will typically assume the financial and logistical responsibility for a seminar; the school alumni could furnish the speakers.

Faculty Visits

Alumni should make it a point to have members of the faculty visit at the grassroots level. Meeting the faculty is one way of helping to "personalize" the school. By way of example, alumni who are involved in local bar organizations could recruit faculty members to be speakers at their local bar programs. In conjunction with the program, a local alumni reunion could be held in order to honor the visiting faculty member. Every opportunity should be seized to get the faculty members out among the alumni.

Publications

Because of the infrequency of publication, the current Alumni Newsletter is an inadequate vehicle for maintaining continuity with the alumni. Additional vehicles of communication might include newsletters directed to the alumni by the President of the Alumni Association, letters from the Dean announcing special events or faculty appointments, and including alumni on mailing lists for the publication of the Center for Employment Relations and the Law (or similar publications). It has been suggested that certain faculty members might seriously consider inaugurating a faculty publication which would address "latest developments" in various areas of the law.

Special Events

Special events which are being held at the law school (i.e., Ladd Lectures, Law Day, etc.) should be showcased to the alumni. Alumni attendance in support of these events should be encouraged. The Alumni Association should consider hosting receptions for the participants in these special events.

Visiting Dignitaries and Proposed Faculty Members

Alumni should be invited to host or visit with visiting dignitaries and proposed faculty members who are under consideration for appointment. These kinds of opportunities would provide for alumni fellowship with faculty members and just make alumni more aware of "what's happening" at the College of Law and how the College of Law operates.

Moot Court/Law Review Alumni Associations

There are a number of student organizations in which alumni participated during their time at school. Alumni associations which are oriented around these activities should be considered. In addition to providing an opportunity for fellowship, these kinds of alumni associations are peculiarly suited to help the student organizations raise funds among the alumni.

Bar Convention

Ways to enhance the visibility of the school during the Florida Bar

Convention should be considered. Additional promotion of the current alumni reception should be considered (i.e., letter from Dean or Alumni Association President to alumni registrants and local area alumni) as well as consideration of adding additional activities.

The following additional programs are designed to enable the alumni to develop a "presence" within the College of Law:

Involvement in Student Groups

There are a variety of student organizations ranging from the Christian Legal Society to the Black American Law Students Association to Mute Court. Alumni should be invited to address these groups through "brown bag luncheons." The students seem to appreciate alumni speaking at the school, and alumni generally are flattered to be asked back. Alumni sponsors or advisors should also be considered.

Guest Lecturers in Class

Many alumni have achieved a high level of expertise in their respective fields of endeavor and have a great deal of substantive knowledge and practical advice to offer students. Faculty members should consider bringing in alumni "guest lecturers" to speak to classes.

Mentor System

A mentor system which would be administered by the Tallahassee Chapter of the FSU Alumni Association should be seriously considered. Local lawyers could become "mentors" of entering freshmen and make it a point to expose them to their practice, take them to lunch, and generally build good will with the students for the Alumni Association.

Receptions - Social Events

The alumni should consider hosting a reception or providing other social events which honor incoming freshmen, graduating seniors, and faculty members. Different groups should be honored at different times, with strong participation encouraged on behalf of those sponsoring the occasion, as well as the honorees.

Alumni Giving

Alumni giving has been miserably low in the past and new approaches

Moot Court Victory Highlights BALSAs Convention

More than 100 students from ten southern law schools attended the regional Black American Law Student Association (BALSAs) convention February 11-12 at the College of Law, but for the host school the highlight came at the Frederick Douglass Moot Court competitions. The Florida State BALSAs chapter team was judged best overall in the region five competition and thus advanced to the national finals in Atlanta. Gary Pickett and Ron Weaver, the winning team members, also submitted the best brief in the case, which was based on the City of Akron abortion ordinance case now on appeal to the United States Supreme Court.

The convention also featured three workshops: on the problems of the Black lawyer in private practice (featuring local attorneys Marva Davis, Bill Scrudts and Harold Knowles); on reforms affecting Black lawyers and strategies to achieve parity in the future (given by Professor David Hall of the University of Mississippi Law School); and on African affairs and strategies for community economic development (with Central Florida Legal Services attorney Hubert Grimes, Greater Miami Legal Services Deputy Director

James Head, and Moses Adeymo, a representative of the Counsel General of Nigeria).

A reception to welcome convention participants was held on Friday night on the 22nd floor of the Capitol and was attended by 200 persons. At the banquet Saturday night, Judge Joseph Hatchett of the 11th Circuit Court of Appeals gave an inspiring keynote address, for which he received a standing ovation.

Also at the convention, first-year student Harold Saulsby was named BALSAs regional placement coordinator for the coming year. Saulsby, elected at BALSAs regional meeting at the College of Law, will put together a workshop on career opportunities for BALSAs Fall regional meeting, and coordinate a seminar for law firm representatives to tell law students about career opportunities and new developments in law.
