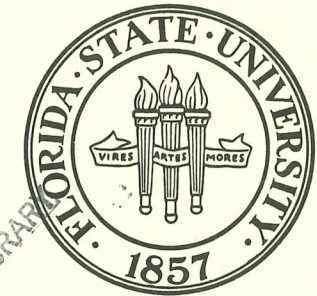

## Conference Pays Tribute to Waldheim

On October 28-30, the Florida State University hosted a conference in tribute to Dr. Kurt Waldheim, former Secretary-General of the United Nations and Distinguished Lecturer of International Law and Relations at Florida State. The conference, THE UNITED NATIONS AND THE AMERICAS: TOWARD THE YEAR 2000, had been in planning for more than a year, but took on a unique timeliness as it convened on the heels of the United States' invasion of Grenada.

Attendance at the conference was excellent. The 187 persons present included many from the University community. Attendance of ten law students was sponsored by the College of Law. In addition, the Florida Chapter of the U.N. Association held their annual meeting in conjunction with the conference.

Distinguished speakers included Bradford Morse, Administrator of the U.N. Development Programme; Robert J. Ryan, Jr., Deputy to the Assistant Secretary of State for Inter-American Affairs; Marco D. Pollner, Director of the Washington Office of the U.N. Economic Commission for Latin America; Donald O. Mills, former Ambassador from Jamaica to the United Nations; Senator Joseph R. Biden, Jr., Member, Senate Foreign Relations Committee; Ambler H. Moss, Jr., former U.S. Ambassador to Panama; German Leiva, President of Miami Free Zone Corporation; Val T. McComie, Assistant Secretary General, Organization of American States. The closing address was made by Elliot Richardson, Chairman of

## Alumni Reunion Draws Record Crowd

In a room filled with sunshine and warmed by a glowing fire, alumni and their guests listened attentively as Judge Kim Hammond spoke at the Alumni Reunion Brunch of his trials encountered on the football field as well as in the courtroom. A 1972 graduate of the College of Law, Judge Hammond has had a varied career in both sports and law, having quarterbacked at Florida State University and in the American Football League while studying and practicing law. He is now serving as Circuit Judge of the Seventh Judicial Circuit.

The Alumni Brunch was held at the Florida State Conference Center on Saturday, November 12, following the Annual Meeting of the Alumni Association. More than 180 persons gathered on the deck in the cool autumn morning for Bloody Marys and then enjoyed Eggs Benedict in the cozy dining room.

Alumni were welcomed by John W. Frost, II, President of the Alumni Association for 1982-83. David W. Wilcox, President for 1983-84, outlined plans for the coming year, including establishment of several local alumni chapters, formation of a Committee on Alumni Financial Affairs, and implementation of an alumni breakfast at the annual Florida Bar Convention next June.

Awards were presented by Dean Slagle to several past presidents of the Alumni Association (see story on page 3). Kenneth L. Connor, on behalf of the Alumni Association, presented five students with \$1,000 scholarships. Terry Russell, Chairperson of the Alumni Association Awards Committee, announced the selection of James Harold Thompson as recipient of the Distinguished

## From the Board

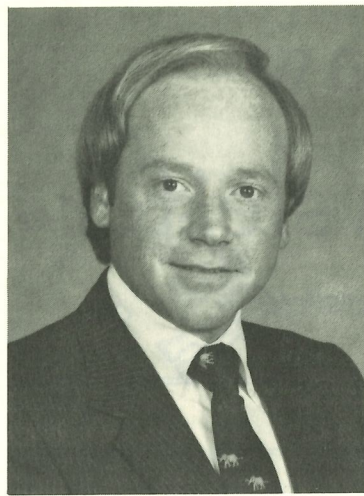

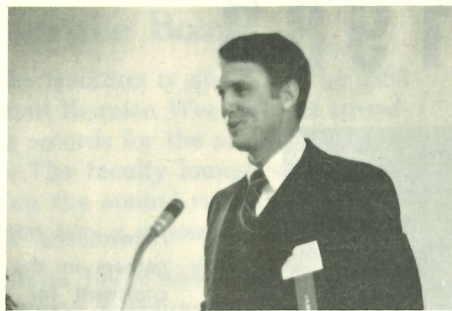

# Placement Update

## Fall Interviews Successful

The Fall 1983 Interview Season was an extremely busy time for the Placement Office and for second- and third-year law students. More than 75 law firms and legal employers scheduled on-campus visits, and approximately 200 students registered with the Placement Office. The availability of several conference rooms in the new Law Library provided greater flexibility in scheduling interviews and allowed firms to visit at convenient times.

Among the firms who recruited on-campus were six Atlanta firms, four of whom were visiting for the first time. Florida firms came from Pensacola, Jacksonville, Miami, Fort Myers and all points between. Another first was a visit from a Mobile, Alabama firm. The increase in the number and range of firms visiting the College of Law is encouraging. Interviewers repeatedly commented on the quality of the students they interviewed.

Assistance was given to students in resume preparation and job search techniques. An interview workshop was held in September. Several alumni participated. Topics covered were *Interviewing with the Large Law Firm*, by David S. Dee of Carlton, Fields, Ward, Emmanuel, Smith & Cutler, Tallahassee; *Employment in State Government*, by Cathy Lannon of the Attorney General's Office; *Opportunities with Small and Medium Law Firms*, by Gene Adams of Pennington, Wilkinson, Gary & Dunlap, Tallahassee; *Judicial Clerkships*, by John Derr of the First District Court of Appeal; and *Importance of Dress and Appearance*, by Todd Phillips of Nic's Toggery.

Although final statistics will not be available until Spring, information accumulated by mid-December indicated that 25 students had accepted positions offered by on-campus interviewers. Others have been invited by firms for second interviews, and several are in the process of making final decisions.

The Placement Office invites employers to register for the Spring Semester Interview Season. Dates are available from January 23 to April 13. To schedule an interview time, call

## Placement Office Expands

After years of a one-person operation from a former storage room, Placement has come into its own. As part of the renovation of B. K. Roberts Hall, the former Law Review suite (Room 205) became the new home of the Placement / Alumni Affairs Office. The new arrangement includes a reception/secretarial area, the director's office, a student resource room and an interview room. A welcome improvement, the new space allows for more efficient and pleasant operation of the office.

Additional staff support has been given to the Placement Office with the establishment of the position of Secretary to the Director. Ms. Debbie Warren was hired in October and will assist in both placement and alumni affairs areas.

## Job Fair 1984 Scheduled

The 1984 Job Fair will be held January 27 and 28 in Orlando in conjunction with the Mid-Year Meeting of The Florida Bar. Sponsored by the Young Lawyers Section, the Job Fair provides an opportunity for law firms to interview students from all five Florida law schools in one location.

Of the fifteen Florida State students attending last year's Job Fair in Miami, three accepted positions with law firms who participated in the Job Fair. Since Orlando is a more convenient location for Florida State students, it is expected that a larger number of students from Tallahassee will attend. Law alumni are encouraged to take advantage of the Job Fair in meeting their hiring needs.

## Lawyers Exchange Available to Alumni

The Placement Office now offers alumni an opportunity to register for employment through Martindale Ser-

vices' National Lawyer Exchange Network (LEXNET). Applications are now being accepted by LEXNET from experienced attorneys who are seeking new legal employment. Attorneys who are admitted to the bar and who are, or have been, employed in a full-time legal position (including judicial clerkships), are eligible to register with LEXNET. Each registered attorney will be contacted by Martindale Services when an employer requests someone with his or her qualifications. ## Oxford Summer Program Open To Alumni

The College of Law will conduct its 12th Annual Summer Program in Law at Oxford, England from July 1 to August 5, 1984. The program is open to graduates of approved law schools as well as to current students in good standing at ABA-approved law schools.

The program attempts to give students an opportunity to study comparative law and the history and development of the English common law. Students can also experience common-law institutions in their native setting.

Faculty teaching in the Summer Program are Professors Bernard Rudden, D. A. Wyatt, Dan Prentice and Jeffrey Hackney of Oxford University and Florida State College of Law faculty members Donna Christie, Orin Slagle and Nat Stern.

Cost of registration, tuition, room and board will be approximately \$1,600. Travel must be arranged individually. ## Professor Graham To Give Ladd Lectures

Professor Michael H. Graham, formerly of the University of Illinois College of Law and now teaching at the University of Miami Law School will deliver the Third Annual Mason Ladd Memorial Lectures at the Florida State University College of Law in March 1984. His lectures will center on a comparative discussion of English and American criminal trials and the problems of witness intimidation.

Professor Graham received his B.S.E. from the University of Pennsylvania and his J.D. from Columbia Law School. After serving as law clerk to Judge Inzer B. Wyatt of the U.S. District Court for the Southern District of New York, he was designated a Reginald Heber Smith Community Lawyer Fellow for 1969-1970. From 1970-1974, he was associated with the New York law firm of Marshall, Bratter, Greene, Allison & Tucker. Professor Graham was on the faculty of the University of Illinois College of Law from 1974 until January 1984 when he joined the faculty of the University of Miami Law School.

The Mason Ladd Memorial Lectures honor the first Dean of the Florida State University College of Law, Mason Ladd, who was an authority on the law of Evidence.

## Grant Received From Attorney's Title Insurance Fund

A grant of \$1000 has been made to the College of Law by the Attorneys' Title Insurance Fund of Orlando. This grant is made annually to each of Florida's five law schools.

The fund, Florida's bar-related title insurer which issues policies through its 5,000 lawyer members, makes the grants each academic year. The money is used to support the teaching of real property law or to assist in faculty-student research in the real property field.

The grant program was initiated at the University of Florida in 1960. Grants have been received by Florida State College of Law since 1967.

## Moot Court Team Wins Award

Moot Court team members Jeff Fleming and Suellen Fagin were named second place winners in the Second Annual Benton National Moot Court Competition in Information Law and Privacy which was held at the John Marshall Law School in Chicago, October 27-29, 1983. The three day competition was underwritten by the Benton Foundation in Washington, D.C., a not-for-profit organization encouraging research in the field of communications.

Twenty-five teams from law schools around the country participated in the competition, presenting oral arguments on the issues of whether a

computer user could be held strictly liable for the escape of personal financial information from its computer; or, alternatively, whether a bank customer has a common law expectation of confidentiality in personal financial information, and if so, whether a bank can be held negligent for the disclosure of such information through the use of *res ipsa loquitur*.

Professor Nat Stern served as faculty adviser to the team of Fagin and Fleming, both second-year students. Their performance in the competition won a \$1,000 grant for the College of Law Scholarship Fund.

## Progress Made In Dean Search

Following Dean Orin Slagle's decision to return to the classroom, a ten member Dean Search Committee was appointed by Florida State University President for Academic Affairs Gus Turnbull. Law Professor Donald J. Weidner is chairing the committee which expects to conclude its search in the Spring.

The Committee has been in touch with hundreds of persons throughout the country. Nominations and applications were submitted to the committee through the closing date of November 1, 1983. The nominees included many highly qualified persons.

During the Annual Meeting of the Association of American Law Schools in early January, the committee interviewed several prospective candidates for the deanship. A number of candi-

dates will be brought to campus to visit with students, faculty, alumni and members of the University administration. The committee expects to make final recommendations shortly after concluding the on-campus interviews.
