## Public Service Fellowship Program to Begin

The College of Law will be beginning a Public Service Fellowship program in the Fall of 1984. Made possible by a \$70,000 grant from the Florida Bar Foundation, the program is designed to attract students who have public service career goals, to help them reach those goals, and to expose all students to the benefits of a public service career. Associate Dean Steven Goldstein, who was involved in organizing the program and who will help direct it, said that "the program recognizes the unique public responsibility of lawyers and seeks to encourage and reward those students who wish to make a commitment to public service." He added that "the program will draw on the unique opportunities available to Florida State University law students to observe and participate in activities of government, the Bar, and other lawyer public service."

Seven public service Fellows will be chosen each year from students beginning the study of law at the College. Three additional fellowships will be awarded to students who have completed their first year of law study. The fellowships will be renewable given satisfactory academic performance and full participation in program activities. The fellowships will range in amount from \$6,000 to \$8,000 during the Fellows' first year, \$4,000 to \$6,000 during the second year, and \$3,000 to \$5,000 during the third year. Fellows will be chosen by a committee consisting of three faculty members appointed by the Dean of the College of Law and two alumni appointed by the President of the College of Law Alumni Association.

## **Moot Court Victory, Alumni** Breakfast Highlight Bar Convention

Alumni of the College of Law found an abundance of excitement and activities during the Annual Meeting of The Florida Bar Convention in June. The resort atmosphere of Innisbrook provided a summertime backdrop for meetings, competitions and social events.

The first Alumni Breakfast for College of Law graduates was held on Saturday morning, June 23, and was attended by approximately 75 alumni and guests. The speaker for the occasion was the new Dean of the College of Law, Talbot "Sandy" D'Alemberte who pointed out many of the achievements of the Florida State College of Law and expressed his excitement upon assuming the leadership of this young but growing law school. On behalf of the Alumni Association, President David W. Wilcox and Past

President John W. Frost presented to outgoing Dean L. Orin Slagle a plaque in recognition of his accomplishments and leadership during his four years as Dean of the College of Law. In addition, the Board of Directors presented him with a gift. Special guests present at the breakfast included Robin Gibson, chairman of the Board of Regents, and the Chief Justice of the Florida Supreme Court, Joseph Boyd.

The Saturday breakfast followed a Friday filled with excitement. A Florida State College of Law Moot Court team defeated a Nova Law Center team in the final round of The Florida Bar Robert Orseck Moot Court Competition. ### From the Dean

This column is a tribute to Orin Slagle who is leaving the deanship to return to teaching: a tribute to a person who has many fine qualities but whose most important trait, to me, is his generosity.

As I have said publicly, Orin is perhaps the most generous person in legal education. He leaves the deanship at precisely the time that the law school has all the resources for distinction. The legislature has continued with its quality improvement program, adding another \$500,000 to the law school budget this past session. For the first time in the history of the school we are now poised to engage in a significant development effort. Steve MacNamara, an FSU law graduate, has been appointed Assistant Dean and he will lead this effort.

This school is now ready to enter its twentieth year anniversary years with prospects of greatness. ## Number of Alumni Judges Increases to Eighteen

Following the beginning of this series in the May Newsletter, it was discovered that there are two additional College of Law graduates serving as judges in the State of Florida. Bringing the total of FSU graduates serving on the bench to eighteen are County Judges Robert K. Mathis (12/73) of St. Johns County and Zebedee W. Wright (12/70) who presides in Broward County. In addition, Susan Roberts, former Polk County Court judge, was appointed to the Circuit Court in May.

Susan Wadsworth Roberts, a Charter Class graduate of the College of Law, was invested as Judge of the Circuit Court, 10th Judicial Circuit, on June 5, 1984. Prior to this appointment, she served as County Court Judge in Polk County for seven years and as Municipal Judge for the City of Lakeland from 1975 to 1976.

Judge Roberts received her B.A. degree in English from Florida State University in June 1966 and entered law school in the Fall of 1966 as one of the three women in the Charter Class of Florida State's new College of Law. After her graduation in 1969, she served as research aide to Judge Liles of the Second District Court of Appeal. From 1971 to 1976, she was a sole practitioner in Lakeland and also served in a part time capacity as a Staff Attorney for the Polk County Legal Aid Society. She served as a part time Public Defender (1972-1973) and part time Prosecutor for the City of Lakeland (1973-1975).

Married to Dan P. Brawley, Judge Roberts has a son, Carson, who is eleven. They reside in Lakeland.



Judge Mathis is married to the former Jane Macauley. They have two children and reside in St. Augustine.




Ronald A. Legendre

Ronald A. Legendre was elected County Court Judge of Osceola County in 1981. Prior to receiving his J.D. degree from the College of Law in 1973, he earned an A.B. degree from Loyola University of New Orleans in 1970.

Judge Legendre established Osceola County's first County Probation Department and its first Pretrial Conference for Summary Claims. He has been instrumental in developing community service programs for adults and a pre-trial intervention program for first time misdemeanants.

Active in civic and community affairs, Judge Legendre is past president of the Kissimmee Lions Club, member and past president of the Osceola County Bar Association, a member of the Knights of Columbus, and past member of the Advisory Committee of the Osceola County Boy's Club.

Charles B. Curry was elected a County Court Judge on September 7, 1982, at age thirty, becoming the youngest person elected to the judiciary in the history of Polk County. After serving in the U.S. Air Force for five years, Judge Curry obtained a B.A. degree from Saint Leo College in 1975. He received his J.D. from the College of Law in December 1978. He served as an Assistant State Attorney, Tenth Judicial Circuit, from April 1979 to October 1980, and then practiced law with the firm of Shannon and Curry until assuming his judicial duties.

Judge Durrance holds a B.A. degree in Government Administration from Florida State. He received his J.D. from the College of Law in March, 1976. While at FSU, he was employed by the Florida Senate to draft legislation.

Radford R. Sturgis

Radford R. Sturgis was appointed County Court Judge in Lee County in 1981 and elected to office in 1982. He is a graduate of the Florida Judicial College and the National Judicial College.

A 1973 graduate of the College of Law, Judge Sturgis received his B.A. degree in Business from Florida State in 1970. Before going into private practice in Cape Coral in 1979, he served as an Assistant State attorney in Lee County from 1974 to 1979.

After a year with the Legislative Reference Bureau in Tallahassee, he served as an Assistant County Solicitor in Monroe County and then as Assistant Public Defender for the 16th Judicial Circuit. From 1971 to 1975, he practiced law in Key West, and from 1975 to 1980, he was Assistant County Attorney for the Board of County Commissioners, Monroe County.

Judge Payne's civic activities include service as District Chairman for the Boy Scouts of America in 1984 and membership in the Elks Club. He is a Mason and a member of the Anchor Lodge. In 1982, he founded the Monroe County Law Curriculum Support Committee. Judge Payne received the Rotary Club Service Award in 1980 and was named Judge of the Year in 1983 by the Key West Political Action Women's Club.

Zebedee W. Wright has served as a County Court Judge of Broward County since his appointment in January 1983. He is running for office this year.

Judge Wright attended Florida A & M University as an undergraduate. He received his J.D. degree from the College of Law in December 1970. Prior to assuming his duties on the bench, he was a sole practitioner.

Judge Wright resides in Ft. Lauderdale with his wife and three children.

## **Placement Update**

#### **Fall Recruiting**

By July 1984, 68 employers were scheduled to interview on campus during the Fall recruiting Season. Last year, a total of 71 interviewers visited the campus, and the number did not reach 68 until September. Therefore, a substantial increase is expected for this year. Included in those already scheduled are four Atlanta firms and two CPA firms (Arthur Andersen and Deloitte, Haskins & Sells).

Second and third year students have been invited to register with the Placement Office. A Placement Handbook will be distributed to them by the first of August. The Handbook includes information on placement services, resume writing, and interviewing techniques.

Interview dates are available in October and November. If your firm or office wishes to reserve a date for Fall interviews, call Elora Harwood or Debbie Warren at the Placement Office (904/644-4495) as soon as possible. Your support of the Placement Program is needed and appreciated.

#### Class of 1983-84


A total of 188 persons graduated in December 1983 and April 1984. Information received by June 1984 indicated that 105 of these graduates (56%) were employed. Only 26 indicated that they were not presently employed; the remaining 57 supplied no information. Many of these graduates are taking the Bar exam this summer. By the time the class is surveyed next January, the number of employed will have increased substantially.

Academic achievement and aptitude of the candidates will be important in the selection process. In addition, the selection committee will focus on the candidate's demonstrated commitment to, and capacity for, public service and potential for leadership.

The Fellows will have a number of responsibilities in connection with the program. All fellowship recipients will be required to spend at least 12 weeks of each summer after the first and second year of law school working in a public service position, for example, with a government agency, a public interest law office, a legal services or aid program, or a legislative committee. The summer obligations of Fellows selected at the end of their first year of Law

## **Tubbs Award Presented to Willard Pope**

The 1984 recipient of the Eugene Tubbs Memorial award is Willard Pope, a second-year law student. On Monday, July 2, a certificate and a check for \$400.00 were presented to Mr. Pope by Dean Talbot "Sandy" D'Alemberte on behalf of the College of Law and Mrs. Margaret Tubbs, the mother of Eugene.

Before he and his wife were killed in a plane crash in July 1978, Eugene Tubbs had amassed a remarkable list of achievements, including finishing both medical school (at the University of Florida) and law school (at Florida State). When he died at 42, Tubbs had served two terms as a Republican representative from Merritt Island. He ran for his legislative seat after he left NASA's Project Gemini, where he served as flight surgeon for astronauts including Neil Armstrong and Ed White.

Citizenship, character, and scholarship form the basis for determining the recipient of the Tubbs Award. Mr. Pope fulfills these requirements in all respects. During his ten years of fulltime employment with the Marion County Sheriff's Department in Ocala, Florida, he obtained both a B.A. degree in Criminal Justice and Public Administration from the University of Central Florida and an MS in Criminal Justice from Rollins College. While serving as a sheriff's deputy, Mr. Pope performed the duties of an investigator, underwater recovery team member, SWAT team commander, administrative sergeant, and community relations unit commander.

As an active member of the SWAT team, Mr. Pope was involved in a high risk situation which resulted in his being shot at close range. He lost the sight in his left eye completely and was legally

blind for a period of two years before recovering vision in his right eye. During this time, he continued to work as an administrative sergeant. He also was instrumental in developing a call-in system for senior citizens and in organizing Florida's first Retired Law Enforcement Officers Association.

Pope received the Marion County Sheriff Department's Medal of Distinction and the Jaycees Officer of the Year Award for 1981 as well as numerous other community service awards. He is a member of the Florida Law Enforcement Officers Hall of Fame.


