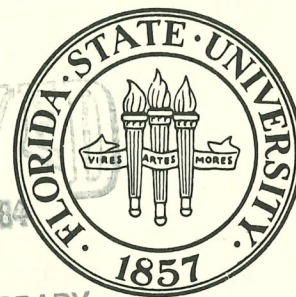

## CLE Seminars Highlight FSU Law Alumni Weekend

Seminars in Trial Practice and Tax will highlight the program planned for the Florida State University College of Law Annual Alumni Reunion Weekend to be held November 30 - December 1 in Tallahassee. The seminars will carry continuing legal education credits and are open to all members of The Florida Bar. A cash bar following the seminars is open to both seminar participants and all alumni. The program will be held at the Florida State Conference Center, one block west of the College of Law.

On Friday night, the Florida State vs. University of Florida basketball game gets underway at 7:30 P.M. A block of 200 tickets was reserved for Reunion registrants until November 2. Although these may be sold before this Newsletter is published, you should check with the Law Alumni Office or the Athletic Ticket Office about the possibility of tickets being available.

Scheduled events begin early on Saturday, December 1. The Annual Alumni Meeting will be held at 9:00 A.M. Results of the election of officers and Board of Directors members will be announced at that time.

Congressman Claude Pepper will be the featured speaker at the Reunion Brunch hosted by the Alumni Association for alumni and guests. The Brunch will be held at the Florida State Conference Center at 10:00 A.M. Bloody Marys will be served at 9:30 A.M.

The Moot Court Alumni Association will host its annual reception fol-

## Book Award Program Announced

The Florida State University College of Law will launch in November a program unique in the area of annual giving by the private sector to higher education. The Alumni Association will sponsor the Law School Enrichment Fund Book Awards Program. Sponsors of the Book Award will help recognize those students who have excelled in a specific course, extracurricular activity, or a specified area of learning while at the College of Law. The success of the program relies a great deal on our alumni identifying sponsors throughout the State to participate for five years.

A sponsor will pay \$3,000, \$2,000 or \$1,000 per year for five years to sponsor a Book Award in a designated area. The sponsor may name the award after his or her law firm, a famous person or even themselves. A portion of the award will go to the student who achieves the highest grade in the specific class or obtains some other goal designated by the faculty. The student will also receive an embossed book and a plaque for his or her accomplishments. A plaque will also be supplied to the sponsor and it will be updated on an annual basis listing each year's recipient.

Unlike other graduate programs such as architecture, engineering, medicine and the like, research grants are not usually available to colleges of law. It is because of this that we must look at approaching law practitioners for the first time in an effort to bring private funds to the College. This will enable us to do those things necessary to increase the credibility and standing of our students within the College. Most of the sponsors' money will go to things such as a distinguished speakers program, recruitment of new

students and faculty, publications, our national championship Moot Court team, emergency loans to students, scholarships, intern programs, extern programs, and a host of other areas not normally funded by the State or contemplated for support in the near future.

If you, or your firm, have achieved recognition and standing in a specialized field, this will be a great opportunity to designate a Book Award in your honor, your firm's honor or perhaps even in recognition of a late member of your firm, a parent or a deceased relative.

It is our hope that a successful Book Awards Program will generate a competitive atmosphere at the College of Law. All too often recognition such as class standing, law review, moot court, etc. are handed out in the first year of law school. Incentive to excel in a certain area can be fostered if recognition such as a book award can be given. Perhaps you missed out on such an honor while at the College. This program will help make sure that the same oversight is not repeated.

It is our hope that our alumni will answer our call and become salespersons for this unique proposal. If all 79 Book Awards are funded, this will give the College of Law Alumni Association a tremendous base from which to operate during the next five years.

Please be aware that in the upcoming weeks the College of Law Alumni Association will be asking graduates of the College of Law to begin participating in our annual giving program in order to help fund such things as class reunions, the alumni directory, the alumni newsletter, job placement

## From the Dean

New deans—like new governors and new presidents—are generally given a honeymoon period, a time when their mistakes are tolerated. Some political traditions hold that the honeymoon lasts about one hundred days. As I write this, I have been on the job for one hundred and two days. Orin Slagle told me that I may be able to get by for a longer period of time because, since I am new to academic administration, I can say, after doing something offensive to academic tradition: "I did not know that."

From all I can tell, I am still in the honeymoon period and this is probably the best time to ask alumni for help. Before doing that, I want to give a brief accounting of the first three months. Much of the detail of this activity is found on other pages of this newsletter and I want to mention only two subjects.

The first is the legal research and writing program. I align myself with those who believe that legal writing is the basic skill which all lawyers must possess. I also agree with the observation that our schools and colleges are not doing an adequate job in training students in writing skills. The law schools cannot simply rail at the undergraduate schools. Our job is to train lawyers, and the FSU Law faculty has stepped up to this responsibility in

a bold way, hiring five full-time law graduates, all with experience in clerking, practice or legislation. These full-time instructors displace a student-taught legal writing program and provide the FSU College of Law with one of the best funded legal writing programs in the country. To put this into perspective, we have one legal writing instructor for every 34 first-year students. This is a rigorous course. It is graded and students are working very hard learning their craft.

We hope that this program will set the tone for our use of the quality improvement funds. We want to place resources into programs which both give more to our students and demand more from them. To date, I believe this program is a great success.

The second accomplishment is the selection and activation of the Public Service Fellowship program. This program is funded by the Florida Bar Foundation from money raised in the interest on trust funds accounts program. With this fellowship, FSU is able to attract law students who have an interest in public service of all varieties. I know that you will hear a great deal about this program, and I hope that you will be helping us locate students who will be interested in this program.

Now to the request.

Printed elsewhere in this newsletter is a calendar of upcoming events. The two events which will first draw the alumni to the school are the alumni reunion and CLE seminars scheduled for November 30/December 1 (the FSU/Florida football weekend) and the Dedication of the Law School Building scheduled for January 25-26, 1985. Justice John Paul Stevens will be the principal speaker at the dedication.

At each of these occasions, we will be talking about how the alumni can help and—hopefully—how they have helped. We need that help to achieve distinction. It can come in various ways. In the area of development, we need support for the Book Award program announced in this newsletter, development of class organizations for organized annual giving, and identification of those people who want to contribute in a very permanent way with the dedication of chairs for distinguished scholars, endowment of professorships or dedication of new facilities. In the recruitment of students, we need your help in identifying the very promising students in your

Don Gifford ('70) served as host for the occasion. He was assisted by members of the new chapter's Board of Directors. They are Craig B. Glid-

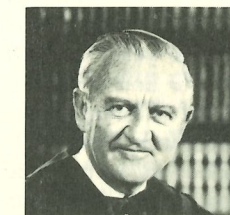

United States Supreme Court Justice John Paul Stevens will dedicate our new library building on Saturday, January 26, 1985. In conjunction with the dedication of the new library, the College of Law will hold a CLE program and several seminars. One planned seminar is an Environmental Growth Management Seminar which could serve as the basis of a blueprint for growth management in the State of Florida. This seminar will be one of the most important held in the State of Florida, and environmental leaders throughout the nation are expected to attend.

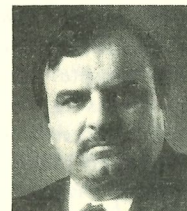
In July of 1985, the College of Law will inaugurate a program of Contin-

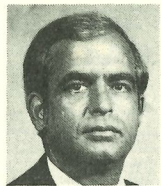

## FSU No. 1 Again on Bar Exam

Florida State University College of Law again tops the list on the passage rate results just released by the Florida Board of Bar Examiners. On the August 1984 Multi-State Professional Responsibility portion of the examination, FSU graduates finished No. 1 in the percent of passing.

On the July 1984 general bar examination, FSU law graduates finished first, ranking more than ten points over the average of other Florida law schools and approximately fourteen points over non-Florida law school candidates examined.

FSU finished by more than two points over the University of Florida and bettered the field average by over four points. FSU College of Law grads are consistently doing better than those of other law schools on all portions of the examination administered by the Florida Board of Bar Examiners. As the quality of our student body continues to improve, we feel confident that we will continue to hold our No. 1 rating.

## 1984-85 Virgil Hawkins Fellows Chosen

Fifteen first and second year students were selected in August to receive a Virgil Hawkins Fellowship for the 1984-85 academic year. The fellowships are named after Florida lawyer Virgil Hawkins who was instrumental in integrating the state law schools in Florida. Each fellowship carries a cash award of \$5,000. ## Dean D'Alemberte, Judge Hatchett Inspect New Law School in New York

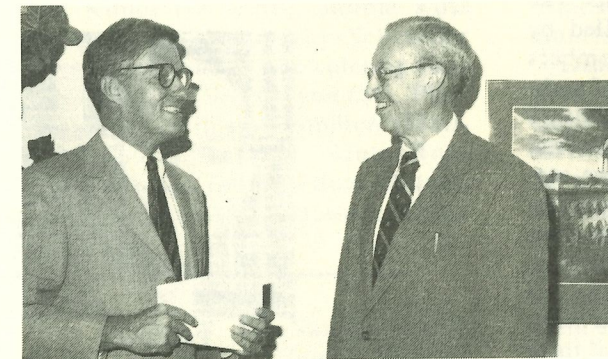
The American Bar Association has appointed Talbot D'Alemberte, Dean of the Florida State University College of Law, to chair the accreditation inspection team of the newly established law school at Queens College, City University of New York.

The inspection team also includes Judge Joe Hatchett of the federal appeals court, Dean Kenneth Broun of the University of North Carolina, Professor Roy Stuckey of the University of South Carolina and Professor Kath-

leen Price, Professor and Librarian at the University of Minnesota.

The inspection team will report its findings to the ABA's Accreditation Committee which in turn reports to the ABA Council on Legal Education, a group chaired by Dean D'Alemberte in 1982-83.

The two Floridians on the inspection team have served together once before in 1983 when they participated in the reinspection of Harvard Law School. Harvard was reaccredited.

# Legal Writing Program Reorganized; Five FSU Law Grads Hired as Instructors

Florida State University College of Law has taken a bold initiative in the teaching of legal writing and research. The College of Law has chosen to emphasize the teaching of these skills and has totally reorganized the legal research and writing program. The new program should improve law students' writing, researching and thinking.

In the past, like many law schools, FSU had relegated the teaching of this course to upper level law students. The new program, however, is staffed by five new, full-time faculty members qualified to meet the challenge of making the course a success. The addition of these new teachers allows the first year class to be divided into five sections for the purpose of this course. Thus, class sizes are kept to less than 35 first year students per instructor. The small class size enables the instructors to give one-on-one attention to students in the development of their writing and research skills.

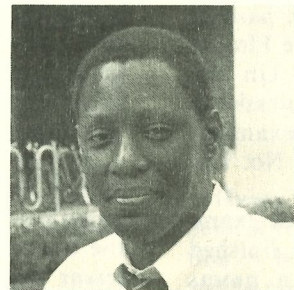
The legal writing instructors plan assignments, design research problems, lecture, conduct small group workshops, critique and grade student papers, and survey the efforts of other law schools to improve lawyerly prose. As a result, first year students get personal, professional instruction in legal writing and research, specially tailored research problems, regular critiques of a series of writing exercises, and expert instruction in legal reasoning and in oral advocacy.

Legal writing and research is a required course during both semesters of the first year. Students receive two semester hours credit each semester. The new course is graded, and students receive a final grade after each semester. In the first semester, students learn basic law library research skills and apply these skills in the preparation of objective legal writings such as case comparisons, client letters, and office memoranda. The focus in the second semester is on sophisticated library skills, legal analysis, and persuasive writing and speaking (advocacy). The course culminates in the preparation of an appellate brief and the oral argument of an appellate case.

Five FSU College of Law alumni have been appointed to develop the new legal writing and research program and to teach the course. The new legal



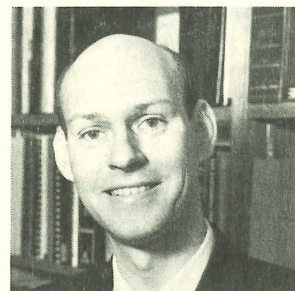

writing and research instructors are young lawyers with outstanding academic backgrounds and legal experiences.

**Patricia Hart Alexander** graduated from the College of Law in 1981 with high honors. She was a member of the FSU Moot Court team that won the National Championship of the American Bar Association National Appellate Advocacy Competition in 1980. She taught legal research and writing as a student at FSU. After graduation, Ms. Alexander worked for two years as judicial clerk to Florida Supreme Court Justice Ben Overton. She was in private practice immediately before joining the College of Law faculty as legal writing instructor.

**John C. Davis** graduated from the College of Law in 1980. Mr. Davis subsequently joined the staff of the Committee on Regulatory Reform of the Florida House of Representatives. As a legislative analyst and, later, a staff attorney, Mr. Davis was responsible for evaluating the continued need for certain regulatory statutes, drafting legislation, and preparing legal opinions on issues raised by members of the House of Representatives. Mr. Davis also brings teaching experience to his new faculty position, having taught legal research and writing as a law student at FSU in 1979-80.

**Joyce Davis** graduated with high honors from the College of Law in 1976. She was a member of the moot court team that won second place for its brief in the International Law Competition. After graduation she worked for two and one-half years with Legal Services of North Florida. She later served as a judicial clerk for two years with the First District Court of Appeal in Tallahassee. Ms. Davis practiced for two years with the firm Davis, Kiesling & McCall and then became a sole practitioner. Ms. Davis brings legal teaching experience to her position as legal writing instructor: she not only taught legal writing as a law student, but she later taught legal services orientation as an adjunct professor of law at Florida State.

**Paul D. Jess** graduated from the College of Law with high honors in 1982. He was a member of the FSU Moot Court team that won the National Championship in the 1982 National Administrative Law Competition. He was also a publishing member of the FSU Law Review. Before joining the faculty of the College of Law, Mr. Jess served for two years as a judicial clerk to First District Court of Appeal Judge Douglass B. Shivers in Tallahassee.

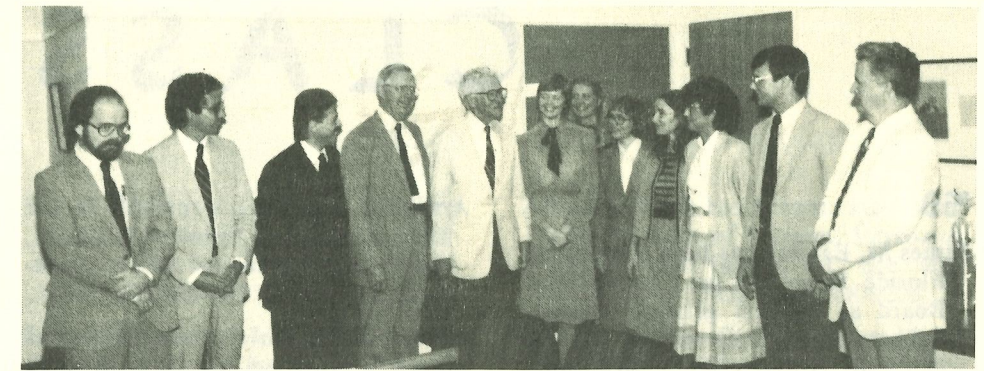

The Florida State University College of Law has developed a unique program made possible by a grant from the Florida Bar Foundation. This program, the Public Service Fellowship Program, is designed to attract students interested in public service careers, and it is funded with a \$70,000 grant from the Florida Bar Foundation.

Three second-year students and seven entering students were chosen by a committee of faculty and alumni. The students will receive fellowships ranging from \$4,000 to \$8,000 per year. The program requires that the Fellows participate in a variety of public service activities, including summer employment and special class work emphasizing public law concerns.

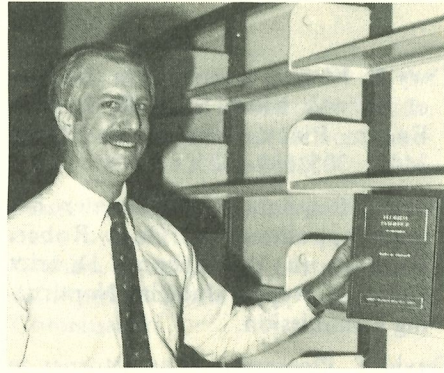

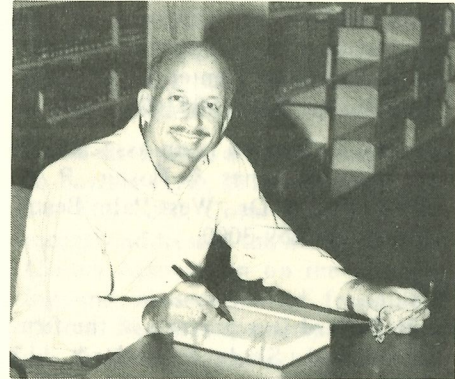

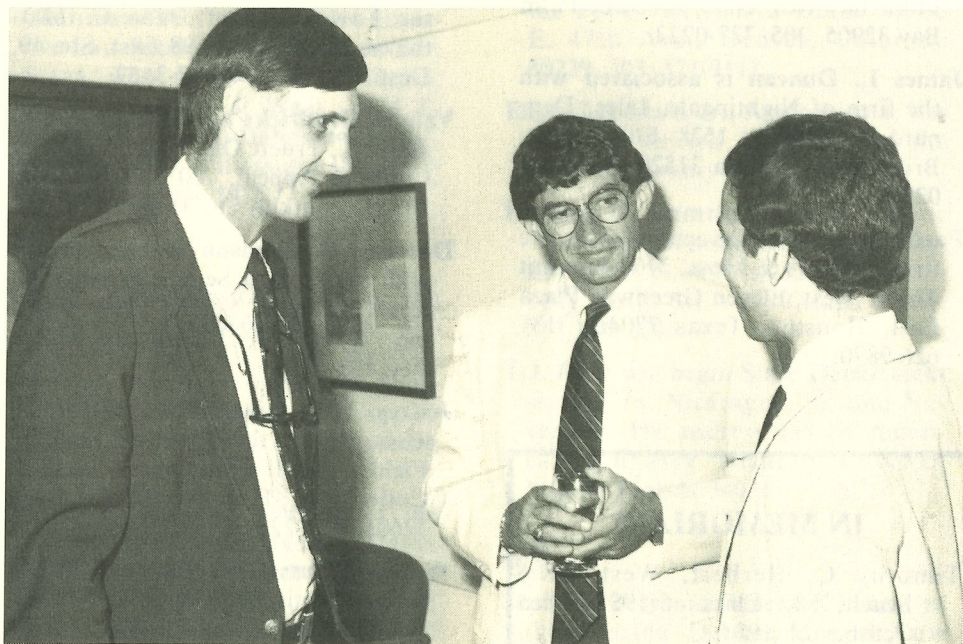

Jack Van Doren autographs a copy of his new book for Dean D'Alemberte.



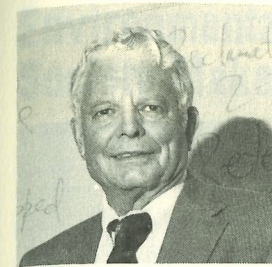

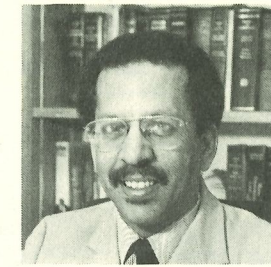

## Bailey and Martin Are 1984-85 Visiting Professors

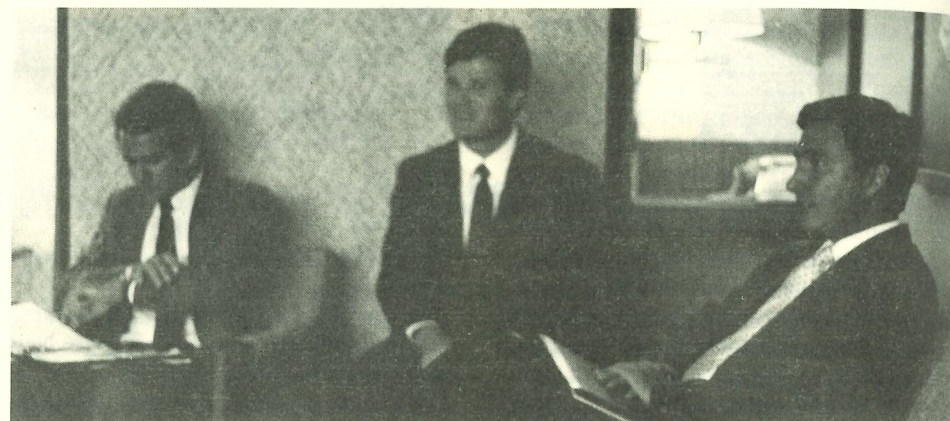
## Fall On-Campus Interviews

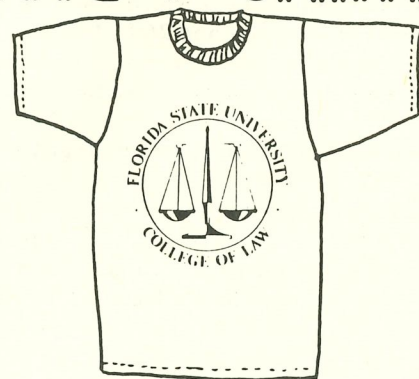

## Environmental Law Society Makes Plans

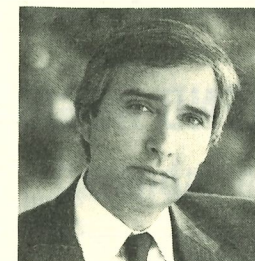
