Good Gulfstream Foundation Gives Endowed Chair, Scholarships

Florida State University is one of ten schools and colleges in Florida to receive funding for scholarships and endowed chairs from the recently formed Good Gulfstream Foundation. James W. Aphthorp, former Florida Deputy Secretary of State and now Executive Vice President of Gulfstream Real Estate Company, announced recently that

five scholarships totalling \$25,000 would be funded this year at Florida State. In the following year, a \$1,000,000 Chair in Growth Management will be endowed at the College of Law.

The Good Gulfstream Foundation, created by and named for Gulfstream Chairman Kenneth M. Good, announced its multi-million dollar commitment to Florida universities and colleges at a press conference and gala dinner in Tampa in November 1986. Good, who is well known for his philanthropic endeavors in the Dallas and Denver areas, acquired Gulfstream in January of 1986. By establishing the Good Gulfstream Foundation to benefit higher education in Florida, Good is repaying favors done for him while he was a student with financial problems.

The goal of the Good Gulfstream Foundation is to provide an economic catalyst that will enable Florida colleges and universities to achieve levels of excellence comparable to the best universities in America. The grant to the University System fits neatly into Chancellor Charles Reed's priorities for improving education in Florida. The endowed chairs will draw top teaching talent to the State, the scholarships will lure more bright students, and the commitment of such funding will make the private sector a partner with Florida's University System in providing quality education.

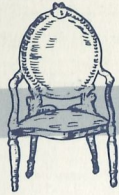

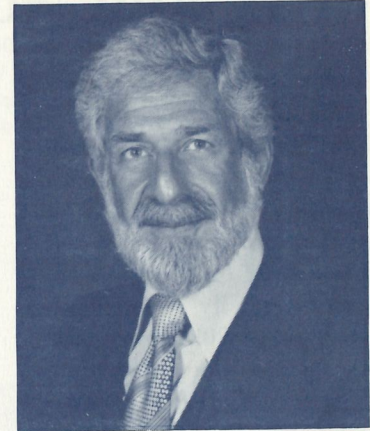
Endowed Faculty Chairs To Be Established At College Of Law

In recent months, the Florida State University College of Law has announced two endowed faculty chairs in addition to the Eminent Scholar Chair in International Law which was established last year.

A gift of \$1 million from the estate of Miami businesswoman Ucola Katzentine will establish the Tobias Simon Chair in Public Law in memory of Ms. Katzentine's

former lawyer, Tobias Simon, a noted civil rights lawyer who served as an adjunct professor at the College of Law for one year. A check for \$600,000, the first portion of the gift, was presented in November.

A chair in growth management was announced on November 21, 1986, in Tampa by James W. Apthorp, Executive Vice President



Tobias Simon

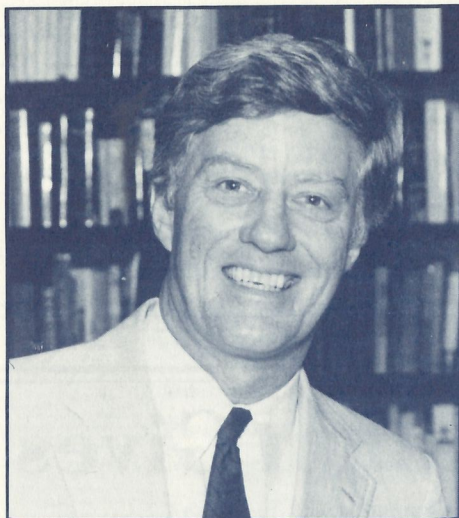
of the Good Gulfstream Foundation. The Foundation, named for Gulfstream Chairman Kenneth M. Good, emphasized its commitment to Florida universities through endowments of chairs and scholarships to several Florida schools. In addition to the endowed chair, the Florida State College of Law received funding for five merit scholarships.

Alumni Reunion And Homecoming Combine For A Full November Weekend Of Activities

Never before have so many exciting alumni events been held in one weekend! Friday and Saturday, November 14 and 15, 1986, were crammed with activities for law alumni as the Alumni Reunion Weekend was held on the same weekend as University Homecoming.

This fall was the 20th year since the College of Law opened its doors in September 1966. To commemorate the occasion, members of the Charter Class of the College of Law were honored as special guests.

On Friday evening, a reception was held for Charter Class members. Approximately 35 of the 92 graduates gathered in Longmire Lounge with their guests. Also attending were faculty members who taught during those early days in Longmire including David Dickson, Francis N. "Pete" Millett, James Clark, William VanDercreek, Charles Ehrhardt and John Yetter. Many tales were told about the first days of the law school when Mason Ladd patrolled the hallways checking notebooks and policing the dress code. Following the reception, the class members went upstairs to relive the hours spent in their one and only classroom.

Earlier events on Friday were a CLE program on "Litigation in Federal Courts" which was held at the Florida State Conference Center and an Awards and Scholarships Day ceremony held at the College of Law to recognize academic achievements of current students and recent graduates.

Law Review members and alumni attended their annual banquet on Friday evening and heard comments by Chancellor Charles Reed. At the same time, the Class of 1976

celebrated their 10th Reunion at the Conference Center with a dinner and a rousing good time! Spearheading the arrangements for the reunion dinner was Ralph Martinez of Orlando. Approximately 70 persons attended.

Saturday saw another round of events. The highlight of the day was the Alumni Reunion Brunch held at the Florida State Conference Center. Again the Charter Class was recognized. The Brunch speaker was Professor David F. Dickson, the only one of the original faculty members still teaching at the College of Law. He reviewed the early beginnings of the law school, pointing out that the first faculty members found themselves not only preparing for class but moving

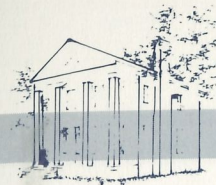

Village Green Changing; Cawthon House Dedicated

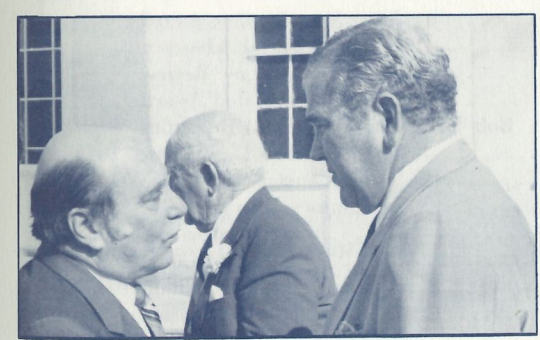

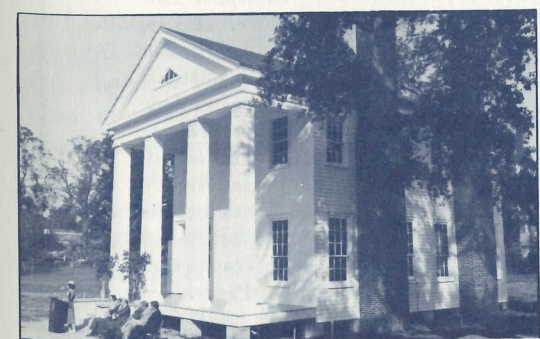
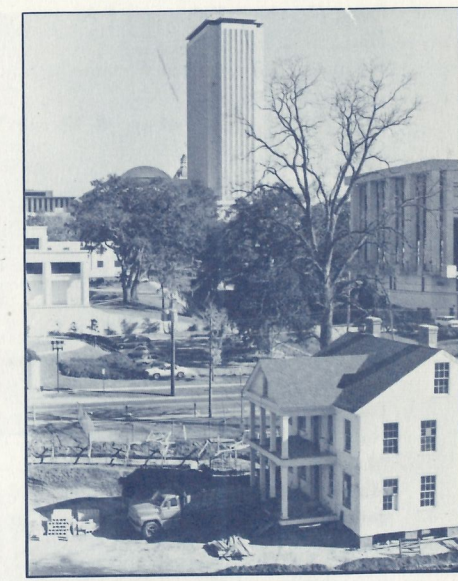

FUNDRAISING

Fundraising Goal is in Sight

With six and a half months of our Annual Giving Drive complete, Secretary-Treasurer Wayne Hogan reports that the Alumni Association has raised over \$145,000 in cash and pledges toward our \$150,000 goal for fiscal year 1986-1987. Most of the funds have come from the very successful Book Awards program which had almost 50 sponsors as of December 31, 1986. The book award breakdown consists of \$80,000 cash-in-hand and \$12,000 in outstanding pledges.

Since it began on November 1, the Alumni Annual Giving Drive has collected over \$31,000 which is more than 40% of this year's \$59,400 goal. Final accounting by class should be ready for the next newsletter. Rounding out the \$145,000 raised thus far are President's Club contributions which total \$14,000 cash to the College of Law. Of this amount, \$4,230 is from faculty contributors to the President's Club. Faculty contributions other than the President's

Club totalled \$6,487, up from \$5,678 last year.

Your generosity is greatly appreciated and your continued support is encouraged. These unrestricted funds allow the College of Law to continue doing things that make the difference in our growth from a good law school to a great law school. Please remember that no contribution is considered too small and that 25% of all contributions go to our students as scholarships and cash awards.

Hogan Scholarship Established

The College of Law announced in January the establishment of the Wayne and Patricia Hogan Endowed Scholarship Fund. A contribution of \$10,000 was given by Mr. and Mrs. Hogan to provide a continuing scholarship for students in the College of Law. Hogan said he hoped that the gift would in some small way repay the law school for all the benefits it has given to him.

Hogan is a 1972 graduate of the College of Law Alumni Association and Chairman of the College's Alumni Award Giving Drive. He has played a key role in helping raise more than \$145,000 in unrestricted funds this year. He and his wife, Patricia, reside in Jacksonville where he is a partner in the firm of Brown, Terrell, Hogan & Ellis.

Fall CLE Programs Draw Record Crowds

Continuing legal education programs sponsored by the College of Law in Fall 1986 attracted a record number of participants.

In September, 1986, a conference on "The Legal and Ethical Dilemmas of Health Care" was held at the Florida State Conference Center in Tallahassee. Approximately 130 persons were in attendance. The conference featured state and national speakers who discussed the health care dilemmas facing society in the next decade.

A conference on Condominium Living and the Aging was sponsored jointly by the College of Law and the Bureau of Condominiums on September 23 and 24, 1986, in Tallahassee. The conference was initiated to discuss and debate topics of significance to the aging population residing in condominiums.

The program on Civil Litigation in Federal Court was held on Friday, November 14, 1986, during the Alumni Reunion Weekend. An overflow crowd of 230 persons registered for the program. Speakers included Judge Peter T. Fay of the U.S. Court of Appeals for the 11th Circuit, Professor Robert Blakey of Notre Dame Law School, Marsha Lyons of Lyons & Farrar, P.A., in Miami, Professor William VanDercreek and Professor Charles Ehrhardt. Leading a panel discussion were Judges William Stafford and Maurice Paul of the U.S. District Court, Northern District of Florida.

Programs offered for Spring 1987 include Litigation in Federal Court (videotaped presentations in January and February) and *Florida's Water Future: Crisis or Opportunity*, a conference held in January. In May and August, an education program for public

defenders will be conducted by the College of Law for the Florida Public Defenders Association. Project Director for the grant is Nancy Daniels, Director of Clinical Programs. Law faculty assisting in the program will be James Alfini and Charles Ehrhardt.

Parents/Spouse Day Brings Families of Students to Campus

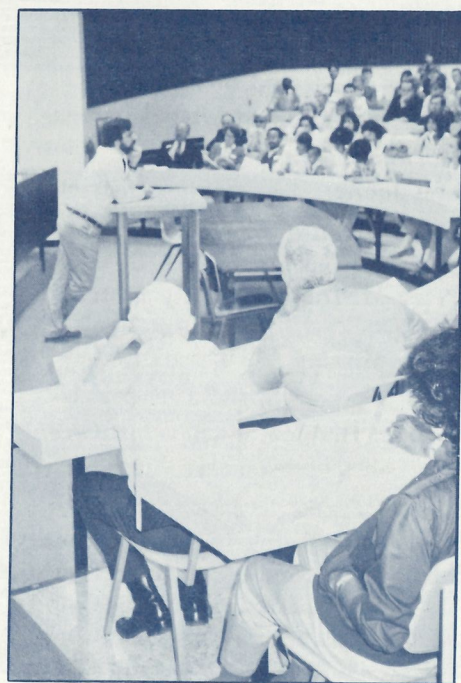

Policy Studies Clinic's Gender Bias Study Receives Wide Attention

The Policy Studies Clinic's monograph, *Gender Bias: Its Effects on Justice in Florida*, has been receiving considerable attention in the press recently. This report details areas where sex bias appears to have an impact on the way the State's legal system deals with people.

Among the report's findings are the following: (1) Most parents who need court ordered child support are women but the enforcement rate is only 28%; (2) virtually all rape victims are women, but 29.2% of sentences are mitigated; and (3) male attorneys continue to earn more than female attorneys with comparable experience.

Several states have found similar discrepancies based on sex in the

context of courts and law practice. They have established task forces, authorized by their state supreme courts, to find the causes and attempt to correct the imbalances. The Policy Studies Clinic's report has recommended that similar steps be taken in Florida.

Since the monograph was released in early September, 1986, the Florida Bar has given official support to this recommendation through a resolution and by committing \$16,000 in funding for further work. Chief Justice Parker Lee MacDonald has approved the appointment of a Supreme Court task force to take up where the monograph left off and has indicated that race bias may be examined as well.

Policy Studies Receives Research Grant

The Institute of Government recently awarded the College of Law's Policy Studies Clinic a STAR research grant of \$28,500. The purpose of the grant is to identify the most pressing budgetary, programmatic, and administrative issues that are confronting state and local governments and changing intergovernmental relations. The project includes three regional public forums, a conference, and a final report that will be submitted to the Legislature and to the Department of Community Affairs (DCA), the sponsoring agency.

Florida is at a critical juncture insofar as the respective roles of state and local governments are

concerned. The state is experiencing change at a sobering rate; forces beyond its control, i.e., aid reduction by the federal government and rapid population growth, are shaping that change. Neither state nor local governments can respond adequately without adopting a more responsive and more flexible intergovernmental system. This project will contribute to the public interest by identifying specific policy changes that should be made. Moreover, it could serve as a model for other states to employ as they attempt to cope with the need for reform.

Completion date for the project is April, 1987.

Oxford Summer Program Open To Law Students and Members of the Bar

For the fifteenth straight year, the College of Law will sponsor its Summer Program in Law at Oxford. The program will be conducted from June 29 to August 6, 1987, and will offer students an opportunity to study comparative law, EEC law, French civil law and the development of the English Common Law where it all began.

The program is open to law students in good standing and to graduates of approved law schools interested in enhancing their legal education. Florida State's program is the oldest of five law school programs in Oxford approved by the ABA.

Six two-hour courses will be offered, four taught by tenured faculty members of the University of Oxford and two taught by F.S.U. faculty. Oxford faculty include Jeffrey Hackney, who has taught in the program since 1974, John Bell, Daniel Prentice and Derrick Wyatt

who is expected to teach at the College of Law in Fall 1987. F.S.U. faculty will be Kenneth Vinson and John Yetter.

This is a chance to learn about the law while residing in Oxford, one of the greatest architectural and cultural treasures of the world. Yugoslav Summer Seminar Includes CLE Program

Barbados, West Indies Is Site Of New Summer Program

The College of Law will conduct its first annual Summer Program in Law at Barbados, West Indies, from June 29 to July 29, 1987. The objective of the program is to give students the opportunity to study comparative law in a Caribbean setting.

Courses will be offered in Comparative Constitutional Law, Foreign Investment Law in the Commonwealth Caribbean, Immigration Law of the United States, and Legal Institutions of the Commonwealth Caribbean. Faculty members include Steve Goldstein and Elwyn Griffith of the College of Law, and A. R. Carnegie, A. D. Burgess, and N. J. O. Liverpool of the University of West Indies.

The program is open to any student in good standing in an ABA approved law school or a Canadian recognized law school and to graduates of approved law schools. The deadline for registration and payment of fees is April 30, 1987.

British, U.S. Judges Learn From Each Other in Oxford Program

Judges returning from the Advanced Seminar in Anglo-American Jurisprudence at Wadham College, Oxford University, England, this summer gave high marks to Florida State University College of Law and the National Judicial College, the sponsoring agencies. The two-week program emphasized a history of the English court system and the British legal profession with an overview of current legal questions facing the United Kingdom today.

Over 40 trial judges from the U.S. were in attendance. Members of the U.S. Supreme Court including Justice John Paul Stevens and state supreme court justices including Florida Supreme Court Justice Ben Overton were among this number. The seminar faculty was drawn from Oxford, Cambridge and the London School of Economics.

Professor Charles Ehrhardt, co-director of the program, stated that the seminar provided insight into the way things are done in this country. One result of the seminar was a look at the two systems and a comparison of their relative strengths and weaknesses. Some held the view that the British do a better job of running their legal system. Ehrhardt commented, "Surprisingly, they do it more effectively, but our legal system is clearly more protective of the individual and individual rights than the English system."

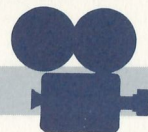

Law School Leads the Way in Video Tape Projects

The F.S.U. College of Law is setting the pace nationally in law-related video by creating new ways to use video tape in the classroom and the courtroom and as a tool to bring the people and their legal system closer together.

Every oral argument presented at the Florida Supreme Court since January of 1985 has been video taped. These video tapes are archived in the Law Library and are available for viewing.

A six-hour Continuing Legal Education program on Civil Litigation in Federal Courts was taped at the Florida State Conference Center in November; it is available by mail from the College of Law CLE Office. The videotape of another CLE program, Legal and Ethical Dilemmas of Health Care, is nearing completion.

Video Discussion Features Fred Friendly of CBS

A roundtable discussion was hosted by the Video Unit of the College of Law in December 1986. The discussion concerned the utilization of video tape to better inform the public about the legal system.

Participants in the discussion included Fred W. Friendly, former President of CBS News and Professor Emeritus of Journalism at Columbia University; Steve Tello, Senior Producer of ABC World News Tonight; John Thomas, Managing Director of Florida Public Broadcasting's *Today in the Legislature*; Ed Herp, General Manager of WFSU-TV; and reporters and news directors from the Tallahassee area.

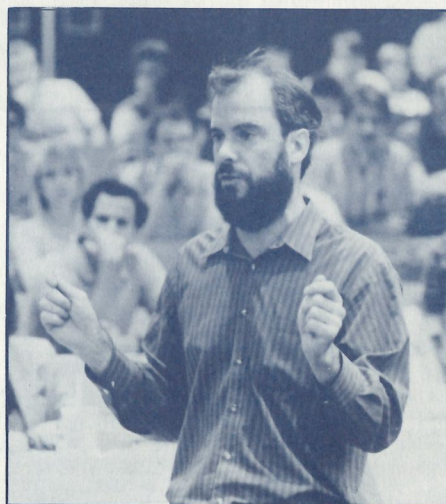
Building on the experience in the Florida Supreme Court, the College

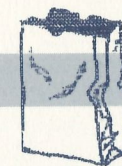
Mason Ladd Lectures Held In November

the Sixth Circuit in Nashville on December 6, 1986.

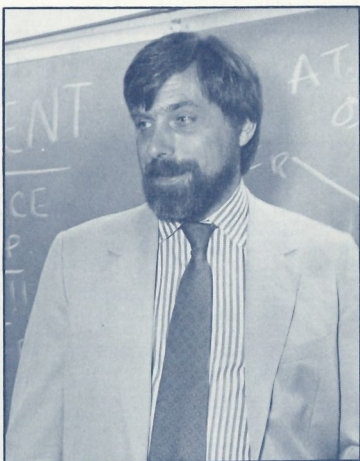

Moot Court Team Wins Back-To-Back National Championships

The Florida State University Moot Court started the year off with wins in the Benton Information and Privacy Law and Starr Memorial Insurance Law competitions.

On October 25, 1986, the team of Sandra Bower Ross and Paul Ullom eclipsed the 41-school field at the Benton Competition, taking the Championship and Best Brief Prizes. Ross, arguing before a final round panel which included U. S. Supreme Court Justice William O. Brennan, Jr., was named Best Oralist. The Benton competition, hosted annually by the John Marshall Law School in Chicago, deals with Information and Privacy Law questions. The 1986 problem concerned a question of liability for an error accidentally printed in a newspaper. This year's Benton team was coached by Professor Nat Stern.

On the heels of the Benton win, the team of Stephen T. Ball and Pamela Mark, coached by Professor William VanDercreek, triumphed in the Starr Memorial Insurance Law Competition in Hartford, Connecticut, on November 14, 1986. Ball and Mark won over the University of South Texas in the final round. The problem involved questions of coverage and insurer's liability in a homeowner's policy and a skydiving accident.

These wins were the sixth and seventh national championships for the Florida State University Moot Court Program.

In conclusion, Chancellor Reed pointed out that the College of Law is breaking out of a bureaucratic mold and sponsoring projects that contribute to the future of Florida, something in which the College can take pride.

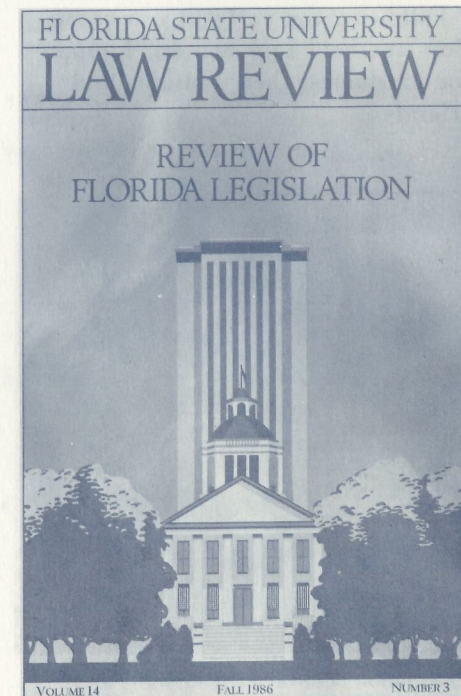
The first article discussed the rights of individuals arrested for DUI, and the next article will discuss tenant rights.

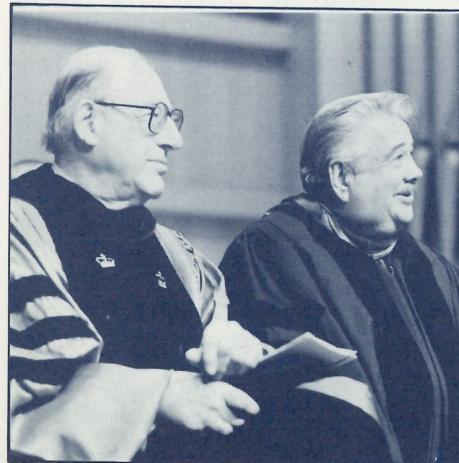
Former CBS President Speaks To December Graduates

Placement Office Reports Increase in Fall Recruiting

The Fall 1986 Recruiting Season was the most active ever seen at Florida State College of Law. On-campus interviews began on September 16 and ran until November 24 with three and four firms visiting each day.
