Langford Family Donates Endowed Chair



Langford

The George R. Langford Family Eminent Scholar Chair in Municipal Corporations was announced in December by FSU President Bernard Sliger.

A gift of \$600,000 from the Langford family will be matched by a \$420,000 contribution from the State's Eminent Scholar Trust Fund to endow the Chair. "To my knowledge," said Dean Sandy D'Alemberte, "there is no other Eminent Scholar Chair focused directly on Municipal Corporations Law in any other school in the United States."

A Tallahassee businessman with a law degree from the University of

Virginia, Langford is well known for his civic activities and for his dedication to FSU programs. He is Chairman of the Board of the FSU Foundation, past president of the Seminole Boosters and a charter member of the President's Club.

A search committee will be appointed to recommend a scholar to occupy the chair. Langford said, "We hope the creation of this chair will attract outstanding students who aspire to a career in local government law."

Langford is chairman of the board of the Municipal Code Corporation, a legal publishing firm he

From The President

I am pleased to report to you on several significant events which have occurred since the last newsletter. First, the Caribbean Law Institute is now a reality. As reported earlier, this cooperative education program is spearheaded by the College of Law and the West Indies Faculty in Barbados. In order to begin the Institute, funds were sought from the United States Congress. I am pleased to report that Congress has approved a \$1.5 million appropriation to begin the program. It is estimated that the cost of the program will be \$1.5 million per year, and we have obtained assurances that we can rely on funding for five years. Thereafter, the program will be funded by private sources who have business interests in the Caribbean. Dean D'Alemberte deserves our congratulations for lobbying the appropriation. Particular thanks should be given to the Florida Delegation in Congress, particularly Congressman Bill Lehman. If you have the opportunity to thank your local congressman, please do this so that they will know that we appreciate their help in funding this excellent program. As you know, the purpose of the Institute is to organize and promote the reform and codification of laws in the Caribbean basin, with particular attention to the laws of trade

Second, we are extremely pleased to announce that the George R. Langford family has committed to establish an Eminent Scholar chair in Municipal Corporations at the College of Law. The \$1 million endowed faculty position is made possible by a \$600,000

contribution from the Langfords, matched by a \$420,000 contribution from the State's Eminent Scholar Trust Fund.

Mr. Langford is a Tallahassee businessman with a Juris Doctor degree from the University of Virginia. He is Chairman of the Board of FSU Foundation, Past-President of the Seminole Boosters and a Charter Member of the President's Club.

This may be the first Eminent Scholar Chair in Municipal Corporations in any law school in the United States. A search committee will be appointed in the near future to recommend a scholar to occupy the Chair. The Law School is to be congratulated for its efforts in obtaining funding for the Chair.

Third, construction continues on the addition to the Law School which will complete the Village on the Green project. We are hopeful that the project will be completed in time for the Alumni Weekend. Last year's Alumni Weekend was very successful, and we look forward to the next Alumni Weekend which is scheduled for September 23 and 24, 1988. Professor Ehrhardt will conduct a seminar on Federal Practice on the 23rd. Many special events are planned. Please make your reservations early as we expect a large turnout.

We look forward to seeing you at the annual meeting of the Alumni Association and the Board of Directors at the Florida Bar Convention in June. We plan to host our annual reception and alumni breakfast during the course of the convention. More specific information will be forthcoming.

Finally, I am pleased to report that the Alumni Directory has been printed and forwarded to all graduates. The publication of this Directory has resulted in the computerization of the Law School alumni records and will make it much easier for us to communicate with you in the future. The Directory was published by Elora Harwood's Placement/Alumni Affairs Office, and Kimberly Boyd, Assistant Director, is to be congratulated for undertaking and completing this yoeman task.

I look forward to seeing you at the Bar Convention in June.

Caribbean Law Institute Receives Congressional Funding

The Caribbean Law Institute is now a reality. The cooperative education program spearheaded by the Florida State University College of Law and the West Indies Faculty of Law in Barbados, has received \$1.5 million from the U.S. Congress.

The purpose of the Institute is to organize and promote the reform and codification of laws in the Caribbean Basin, with particular attention to laws of trade and commerce.

FSU Law Dean Talbot "Sandy"
D'Alemberte stated that the institute will be a unifying force in
the Caribbean for nations interested in trade in the region.

"We are thrilled with the vote of confidence in the form of funding from the Congress," said


impressed with the way our Florida congressional delegation worked ..."


The cost of the Caribbean Law Institute is estimated at \$1.5 million per year for five years. After five years, the funding will be reviewed and CLI will attempt to develop funding from private sources including practitioners and businesses involved with trade in the Caribbean.



Village Green Completion Remains on Target

The Village Green construction is on schedule, and a summer 1988 completion date is expected. Two completely restored houses are on site and are being used for offices, small seminars, and receptions.

A third house, the Damon-Lewis House, was moved to the site on January 19, 1988. The house was originally built in 1937 and located on the corner of Duval and College Avenue. Many of you will

remember that it was once Vardi's Gift Shop and also the home of Harold Lewis's law firm. The City of Tallahassee donated the house to the College of Law to make way for




Construction on the new addition began with cranes placing the steel supports.

a large hotel and parking garage complex opposite City Hall.

The exterior of the Rotunda Building is almost completed, and it is now possible to visualize what has been only an architect's drawing for the past two years. The Rotunda and the Village Green, when completed, will be a source of great pride for Florida State University as well as the City of Tallahassee.

The College of Law is very grateful to the many supporters of this project and asks that you continue to make contributions toward the furniture fund. It is hoped that the first floors of each of the houses can be furnished in keeping with their historic beginnings.

The Sarah Payne Cawthon House

Built in 1834, the Sarah Payne Cawthon House is of Greek Revival Style, having square Doric Columns which form an entrance portico. Simplicity is one of the best features of the house. The interiors are grand in scale, with 12 foot ceilings and large, well proportioned windows.

The house is a two story structure with a wide hallway and large rooms. The original house had stairs leading from the first floor to a basement dining room. The kitchen was a separate building in the backyard. And there was not one closet in the entire house!

In 1924, Mr. and Mrs. F. E. Harrison bought the house and made several changes to make it more livable and up-to-date. During the next 25 years, the house became a center for social life in Tallahassee. The Harrison

daughters' wedding receptions were held in the "twin parlors" of the main floor and countless dignitaries, governors and foreign royalty were entertained. It was the epitome of gracious living.

The house was bought in the late 1960's by Sarah Payne Cawthon after demolition had already begun. However, two of the original

mantels are still there, and the original heart-pine floors exist in the downstairs hall and the upstairs rooms.

Donated in 1986 to the College of Law by Sarah Payne Cawthon's two daughters, Mrs. Sarah Shaw and Judge Anne Booth, the house was moved to the Village Green and restored to its former beauty.

The Johnson-Caldwell House

The Johnson-Caldwell House was built before 1850 by George C. Johnson during a time of prosperity brought on by rising cotton prices. Around 1900, the land around the house was developed as a pecan orchard, and the house served as the manager's home.

Millard Caldwell bought the

house when the pecan company's lands were being sold off in 1941. At that time, he was serving in the U.S. House of Representatives. He became Governor of Florida in 1945, Florida Supreme Court Justice in 1962, and Chief Justice in 1967. Mrs. Mary Caldwell continued to occupy the house until her death in February 1986.



The parlor of the Caldwell house has been furnished with some of the original furniture. The Johnson-Caldwell house is typical of Greek Revival residences built in the North Florida area in the 19th century. It is a 2½ story wood frame structure with a gable roof. Nearly all of the interior woodwork is original. There are four-panel doors throughout the house, and the flooring is heart pine. The original windows are sixover-six double hung sashes. Two interior crosswall chimneys provide back-to-back fireplaces on each floor.

In July 1986, the house was donated to the College of Law by Mrs. Sally Caldwell McCord and moved from its original location on Old Bainbridge Road to the Village Green. Now fully restored, the Johnson-Caldwell House was dedicated on May 15, 1987, and stands ready for use by the College of Law.




FACULTY NOTES



D'Alemberte Endorsed by Florida Bar and Alumni Board for ABA Presidency



Weidner and Jacobs Assist Students with IRS Suits

Tax professors Joe Jacobs and Don Weidner have gotten the attention of the Internal Revenue Service through their efforts to assist 32 FSU graduate students hit with audits on their 1984 taxes.

The students had been ordered to pay \$500 to \$1,500 apiece. They are graduate assistants who received stipends for research and training. FSU, like many universities, does not withhold taxes when students' earnings are for teaching or research required for completion of a degree.

The filing of law suits in the U.S. Tax court has prompted the suspension of audits in the district and an expected visit from a legal representative of the IRS district office in Jacksonville. The meeting was requested to better understand the university's financial-support process for graduate students.

The Chronicle of Higher Education, considered the Wall Street Journal of academia, said that the FSU lawsuits prompted the IRS to back off.

Professor Joe Jacobs is recovering from recent surgery. He will return to teaching in the summer semester.

Sixteenth Oxford Summer Program Scheduled

The College of Law will sponsor its sixteenth Summer Program in law at Oxford from June 27 to August 4, 1988. The program will offer students an opportunity to study comparative law, EEC law, French civil law and the development of the English Common Law where it all began.

This is a chance to learn about the law while residing in Oxford, one of the greatest architectural and cultural treasures of the world. Cost of registration, tuition, room, board and program fees is approximately \$2,400, depending on the dollar/pound exchange rate prevailing on April 1, 1988.




Law Review Announces New Board Members and Topics for Next Edition

Dante Fascell, U.S. Congressman from the Nineteenth Congressional District of Florida, was the commencement speaker at the College of Law graduation ceremony in December.



On May 25-27, 1988, international and national policy makers will convene in Tallahassee to discuss the importance of preserving and expanding the multilateral trading system which has operated



Arther Dunkel, the Director-General of GATT, will provide the keynote address for the conference, which will focus on the policies and mechanisms of the current Uruguay Round of trade negotiations.

Appellate Conference Features Brief Writing and Oral Argument Training

Florida Supreme Court Justices Rosemary Barkett and Steven Grimes highlighted the Public Defenders Advanced Appellate Advocacy Seminar which was held at the College of Law on November 13 and 14, 1987. Speaking to a group of 35 appellate public defenders from across the State, the Justices lectured and answered questions on brief writing and oral argument skills.

Swain of the FSU Department of Religion, David Schultz, the Editorial Editor of The Lakeland Ledger, and Patricia Leary, the Director of the College of Law's Research and Writing Program.

Another session involved the presentation of oral arguments which were critiqued by five members of the FSU Theatre Department.

The two-day conference received high evaluations from the participants, and plans are underway to repeat it next year. The conference was funded by a \$103,750 grant from the U.S. Department of Justice which was awarded to the Florida Public Defenders Association in 1987.

Faculty Shuts the Door on CLE Credit for Law Classes

Two for-credit law school classes this Fall were opened on a limited registration basis to lawyers: the week-long Business Transactions and Skills, taught by Conflict Management, Inc. of the Harvard Negotiation Project, and Professor Pat Dore's "Florida Administrative Practice" course which was held

two nights a week for the entire

The faculty, however, voted to discontinue this practice after students circulated a petition expressing concern that " ... the impact on students could range from the illogical scenario of being excluded from a limited enrollment

class or being forced into an overenrolled class ..." and "... a law school should not subject itself to the perception that it is a prostitute for the Bar."

This faculty policy does not foreclose the auditing of classes by lawyers who have the faculty member's approval.

Policy Studies Clinic Projects Involve Current Issues

At Policy Studies, we solve problems the old fashioned way—we think them through.

This best sums up the philosophy of the Policy Studies Clinic, the College of Law's "legal think tank." In a world where students are trained to be lawyers in an adversary system, students who work at Policy Studies have an opportunity to study objectively a variety of legal issues, issues that often have far-reaching implications. The clinic employs eight law students who serve as Policy Studies Fellows under the supervision of the Director, Professor Donna Christie, and Associate Director, Patricia Leary.

The Clinic's most significant project this year continues to be Professor Christie's grant-funded work on a State Ocean Policy. Professor Christie, the College's environmental law expert, is also serving as legal adviser to the Governor and Cabinet's Beach Access Advisory Committee. She has been drafting proposed beach access legislation as well as accompanying commentary. Policy Studies will publish a monograph on Beach Access that will include the proposed legislation, Professor Christie's commentary, and articles on beach access.

Policy Studies gives students a unique opportunity to work on timely legal questions with statewide impact. Florida has recently been the focus of national attention because of three issues: the sales tax on services, medical malpractice, and the concealed weapons law. Policy Studies has been involved in all three. During the September special session, the clinic was asked to advise the legislative leadership on two questions: whether the legislature could

constitutionally repeal the services tax without replacing the revenues, and whether repeal of the services tax could be conditioned upon the approval of the voters in a statewide referendum. Associate Director Patricia Leary has written an article on the second issue for the legislative edition of the Florida State University Law Review.

On the malpractice issue, the Governor's office asked Policy Studies to prepare a comparison of the tort systems of eleven states, including Florida. The report will be of great benefit in placing Florida in a nationwide perspective and in identifying those areas of tort reform that Florida has not pursued as vigorously as it might.

The Secretary of State asked Policy Studies to prepare for concealed weapons licensees a pamphlet on the use of deadly force. The pamphlet, written in a deliberately simple and non-

legalistic question-and-answer form, uses examples from actual cases. As a result of this work, Ms. Leary has appeared on a televised panel discussion on the subject of deadly force. The program, structured as a socratic dialogue among twelve panelists, including state attorneys and members of the press, and the moderator, Fred Friendly, aired in January.

Policy Studies sponsors several conferences each year. Policy Studies' conference on Forging Partnerships in Land and Water Management, held July 31, 1987, in Orlando, was a tremendous success. It attracted nearly 200 state and local government officials, representatives of water management districts, and environmental law practitioners. The clinic has published the opening address of Thomas Pelham, Secretary of the Department of Community Affairs, entitled "The Florida Approach to Comprehensive Planning: The Opportunity for Integrating


