Bill Number: HB 1402

Sponsors: Rep. Fulford

Relating to: Litter

SUMMARY & ANALYSIS:

Redefines "litter" to add any lighted or unlighted cigarette or cigar, or any flaming or glowing material.

Presently, cigarettes and cigars are not specifically categorized as litter.

In addition to present prohibitions, this bill makes it unlawful to litter on any portion of the right-of-way of a public thoroughfare.
