S 237 GENERAL BILL/2ND ENG by Judiciary-Civil (Similar CS/CS/S 155, Compare CS/H 884)

Alternative Dispute Resolution: deletes authorization for appropriation of revenues or levying of service charge, pursuant to valid public purpose, to fund certain conciliation services; requires assignment of certain disputes involving child custody, visitation, & child support to existing mediation programs; provides that mediators & arbitrators shall have certain immunity, etc. Amends
