**S 736 GENERAL BILL/CS/1ST ENG by Finance, Taxation and Claims;
Walker (Compare CS/H 433, H 1331, CS/1ST ENG/S 256, CS/1ST
ENG/S 1164)**

Ad Val Tax Prepayment/Installment; amends provision which allows prepay-
ment of estimated tax by installment method; revises application & notice re-
quirements & specifies that reapplication is not required under certain circum-
stances; provides for exemption of tangible personal property loaned or leased
to an exempt entity under certain conditions; provides applicability. Amends
197.222, 196.192. Effective Date: 06/26/89 except s. 1 effective 07/01/89.
