## S 988 GENERAL BILL/CS by Transportation; Beard (Identical CS/H 847)

Motor Vehicles/Mobile Homes/Liens; provides revised procedure re liens on motor vehicles & mobile homes when there is more than one lienholder; provides for filing of certain notice with lienholders; provides that owner of motor vehicle or mobile home may file notice of lien on motor vehicle or mobile home in favor of person prior to execution of security agreement, retain title contract, conditional bill of sale, chattel mortgage or similar instrument, etc. Amends 319.24,.27. Effective Date: 01/01/90.
