Education/Scholarships; directs State Bd. of Education to include certain provisions for superintendents; renames Student Loan Forgiveness Program; revises language re Fla. Undergraduate Scholars' Fund; revises eligibility criteria for state tuition vouchers; revises student eligibility for certain scholarships, loans, grants, & state financial aid; creates Fla. Private Student Assistance Grant Fund, etc. Amends Chs. 121, 230, 231, 240, 295. Appropriation: \$250,000. Effective Date: 07/01/89 except as otherwise provided.
