I. SUMMARY:

A. PRESENT SITUATION:

University Hospital - Jacksonville (UHJ) is a unique facility within the University of Florida's Health Science Center's educational program. It is unique in that:

- a. It is the only community teaching hospital in which all fullstaff are University of Florida faculty.
- b. Almost all of the health educational programs under the aegis of the Jacksonville Health Education Programs, Inc. (JHEP), a Board of Regents approved entity of the University of Florida, are centered within the University Hospital Jacksonville.
- c. In the Board of Regents approved E&G budget of the University of Florida Health Center there is presently \$3.5 million annually that support directly JHEP/University Hospital including 28 F.T.E. faculty lines specifically allocated to University Hospital.
- d. The University of Florida Health Science Center and University Hospital have executed a full affiliation agreement and the Board of Regents has designated UHJ as an "urban campus" of the UF Health Science Center.

All UF staff physicians at the UHJ are presently in a BOR Self-Insurance Trust fund. Thus, in all medical liability actions, it would be a great fiscal and programmatic advantage to have both the physicians and their primary hospital locus in the same trust fund - as has been demonstrated between the UF Health Science Center and Shands Hospital and the University of South Florida and the H. Lee Moffitt Cancer Center.

B. EFFECT OF PROPOSED CHANGES:

What is being requested by the present proposed legislation is "authorization" for University Hospital of Jacksonville (UHJ) and Faculty Clinic, Inc. to enter into a BOR self-insurance trust fund. UHJ is asking only to be part of a self-insurance fund and is not requesting sovereign immunity. This Jacksonville area self-insurance trust fund under the BOR is a separate and distinct fiscal entity and would not play any role in the fiscal integrity of the existing self-insurance trust funds at UF and USF.

- 4. By the combining of all exposure in a single program, result in the maintenance of a viable self-insurance program. The entities involved are predicting and anticipating a significant dollar savings by a joint self-insurance venture between the BOR and UHJ.

I. SUMMARY:

A. Present Situation:

Section 240.213, F.S., authorizes the Board of Regents to provide general and professional liability insurance for Board of Regents members, students, faculty, professionals, including health care providers practicing by virtue of their employment by a state university, and employees of the Board of Regents. Under this authority, the Board of Regents currently provides professional liability insurance through the BOR self-insurance program for university faculty, residents, and interns practicing in the state's teaching hospitals.

The BOR is specifically authorized to provide general and professional liability insurance for the not-for-profit corporations operating J. Hillis Miller Health Center at the University of Florida and Moffitt Cancer Center at the University of South Florida by s. 240.513, F.S., and s. 240.512, F.S., respectively. This insurance is also provided through the BOR's self-insurance program.

The BOR does not have statutory authority to provide professional or general liability insurance for the not-for-profit corporations operating University Hospital of Jacksonville or Faculty Clinic, Inc. University Hospital of Jacksonville serves as a teaching hospital for the University of Florida College of Medicine. The hospital is currently insured by a wholly owned captive insurer in the British Cayman Islands. Faculty Clinic, Inc., which will function as an outpatient facility of University Hospital of Jacksonville, has not yet been constructed and is, therefore, not yet insured. The clinic is projected to begin operations in the fall of 1990.

B. Effect of Proposed Changes:

The proposed bill would authorize the Board of Regents to provide general and professional liability insurance for University Hospital of Jacksonville and Faculty Clinic, Inc. through the BOR self-insurance program.
