**S 81 GENERAL BILL/1ST ENG by Commerce (Similar H 1729)**  
Economic Development Agencies; (OPEN GOVERNMENT SUNSET REVIEW) amends provision which provides exemption from public records requirements for certain information received by such agencies re proposed manufacturing or business activities; revises period during which such exemption applies; saves such exemption from repeal; amends certain provision which provides procedures for levying tourist development taxes, etc. Amends 125.0104, 288.075, 1162, 1163. Effective Date: 10/01/89.
