**S 612 GENERAL BILL/CS/1ST ENG by Insurance; W.D. Childers  
(Similar CS/H 1659)**

Insurance Companies/Investments; provides certain exemptions from limitations on insurer investments; deletes provisions which permit certain investments without consent of Insurance Dept.; provides authority for insurers investing in investments not specifically authorized under certain circumstances without dept. approval. Amends 625.305,.331. Effective Date: 10/01/89.
