# S 683 GENERAL BILL/CS by Commerce; Gardner (Identical CS/H 1121)

Financial Institutions; revises requirements re investigations by Banking & Finance Dept.; provides for application of provisions re issuance of cease & desist orders & removal of officers to other persons participating in conduct of affairs of institution; provides for access to, confidentiality of, & penalty for disclosure of books & records of such institutions; authorizes branch banking in state & subsidiaries to accept deposits, etc. Amends F.S. Effective Date: 10/01/89.
