H 1346 GENERAL BILL/CS/1ST ENG by Criminal Justice; Silver (Similar CS/S 182, Compare H 617)

Communications Interception: authorizes certain persons to provide technical assistance under specified circumstances to persons authorized to intercept communications; prohibits disclosure of such interception; authorizes interception of communications for violations of certain additional crimes; authorizes court to order use of mobile interception device; provides for emergency interceptions, etc. Amends Ch. 934. Effective Date: 10/01/89.
