S 116 GENERAL BILL/CS/1ST ENG by Transportation;
Transportation (Compare H 1743)
Motor Vehicles/Accident Reports; (OPEN GOVERNMENT SUNSET RE-
VIEW) provides minimum amount of damage to vehicle or other property before
requiring certain notice; increases minimum amount of damage required before
written accident report is required from driver of motor vehicle; provides that ac-
cident reports by law enforcement officers in certain cases shall be discretionary;
revises language re confidentiality of certain accident reports, etc. Amends
316.065,.066, 324.051. Effective Date: 10/01/89.
