State Fiscal Affairs/Local Govt. #### I. SUMMARY:

A. Present Situation:

Chapter 216, Florida Statutes relates to planning and budgeting. Section 216.011, F.S., provides definitions for the purpose of fiscal affairs of the state appropriations acts, legislative budgets and approved budgets.

B. Effect of Proposed Changes:

The bill defines the appropriation category "Grants and Aids to Local Governments and Non-profit Organizations - Fixed Capital Outlay" for purposes of state fiscal affairs, appropriation acts, legislative budgets, and approved budgets. The category broadly includes grants to local governments and non-profit organizations for fixed capital outlay and related operating capital outlay needs and for infrastructure and growth management needs related to local comprehensive plans. The bill permits funds in this category to be advanced to local governments and non-profit organizations in part or in whole.

The effect of this definition will be to recognize the appropriation of certain funds to local government and non-profit organizations for capital projects, rather than the current aggregation of both operating and capital appropriations.

Section 2 appropriates to the State Working Capital Fund any funds appropriated from the State Infrastructure Fund for projects which are vetoed by the Governor.
