**H 548 GENERAL BILL/CS/CS/1ST ENG by Appropriations; Criminal Justice; Arnold (Similar CS/1ST ENG/S 1177)**  
**Title Insurance/Criminal Penalties; provides criminal penalties for conversion or misappropriation of funds received or held in escrow or trust; provides title insurer & title insurance agent administrative surcharge; provides additional bond & deposit requirement re title insurers; revises language re continuation of title insurance agent's license, etc. Amends Chs. 624, 626, 627. Effective Date: 10/01/89 except as otherwise provided.**
