I. SUMMARY:

A. PRESENT SITUATION:

Currently s. 790.221 F. S., makes it unlawful for any person to own or to have in his possession any short-barreled rifle, shotgun, or machine gun which is readily operable. A person convicted of this offense is guilty of a felony punishable by imprisonment not to exceed five years. A felony of an unspecified degree is a third degree felony.

Section 790.221 F. S., does not apply to antique firearms, or firearms which are lawfully owned and possessed under provisions of federal law.

B. EFFECT OF PROPOSED CHANGES:

HB 748 makes it a second degree felony for any person to own or to have in his care or possession, any short-barreled rifle, short-barreled shotgun, or machine gun which is, or may be, readily operable. Once convicted under this section, HB 748 provides for a mandatory minimum sentence of five years.

Antique firearms, or firearms which are lawfully owned and possessed under provisions of federal law remain exempted from this section.

C. SECTION-BY-SECTION ANALYSIS:

Section 1 creates a second degree felony for possession of

specified firearms punishable with a mandatory minimum term of five years.

Section 2 provides an effective date of October 1, 1989.

III. LONG RANGE CONSEQUENCES:

This bill is consistent with the State Comprehensive Plan, s. 187.021, F. S., as its goal is the protection of the public by preventing, discouraging, and punishing criminal behavior.

IV. COMMENTS:

HB 748 requires imposing a mandatory minimum term of five years imprisonment for violations of s. 790.22 F. S., however, it does not specifically prohibit the award of gain-time. Therefore, a person sentenced under this section would be eligible to receive gain-time pursuant to s. 944.275.

This bill is consistent with the Committee Mission Statement in that it enables the Criminal Justice System to operate effectively and responsibly.

This bill is also consistent with the Policy Statement in that it makes mandatory incarceration time for offenders who commit crimes with guns.
