### I. SUMMARY:

A. PRESENT SITUATION:

Section 413.08, Florida Statutes, provides for the rights of disabled persons. Included in these statutory rights are the right to equal accommodations, and the right to be accompanied by guide dogs. Specifically, persons who are deaf, blind, visually handicapped, or otherwise disabled, are entitled to equal accommodations on all forms of public transportation, and at all hotels, resorts, or other places of public accommodation where the general public is invited. Every deaf person, or person who is totally or partially blind, also has the right to be accompanied by a guide dog without extra charge; however, the person is liable for any damage done by the guide dog. Similarly, trainers of guide dogs have the right of access to public places while in the process of training the dogs, and the trainers are likewise liable for any damages. Section 413.08(7), Florida Statutes.

Disabled persons also have the right to rent or lease housing accommodations without regard to any physical disability, and disabled persons may not be discriminated against in employment because of their disability. Section 413.08(5), Florida Statutes. Violations of any provision of s.413.08, Florida Statutes, is a misdemeanor of the second degree.

Currently, there is a national program which trains capuchin monkeys to assist paraplegics and quadriplegics by handling simple tasks such as picking up objects, opening doors, turning pages, or turning light switches on and off. > bald-faced, monkeys of the genus <u>Cebus</u>, native to South America. There is a breeding program at Disney World which supplies these monkeys to Boston University for placement in family situations for training purposes. It appears that on a national level, about 40 disabled persons are being assisted by monkeys. About 70 monkeys are currently in the training program, with 10 being trained in Florida.

B. EFFECT OF PROPOSED CHANGES:

CS/HB 838 provides that capuchin monkeys may accompany paraplegics or quadriplegics in public places in the same manner that guide dogs may accompany the deaf or blind. Similarly, trainers of capuchin monkeys will have the same right of access to public places. The trainers must be paid employees of a training organization to receive the access benefits provided by this bill.

C. SECTION-BY-SECTION ANALYSIS:

Section 1 of the bill provides that paraplegics and quadriplegics may be accompanied by capuchin monkeys in public places in the same manner, and with the same liability restrictions, as is currently provided for guide dogs for the deaf and blind. This section also extends a right of access to trainers of capuchin monkeys. These trainers must be a paid employee of a training organization, and shall not include volunteers chosen to raise the animals.

Section 2 provides an effective date.
