H 1408 GENERAL BILL by Cosgrove (Compare S 1216)

~~Decedents' Estates/Filing of Claim~~; changes time for filing claims; provides for contents of notice to creditors; deletes filing requirement; provides clarifying language re which persons are interested persons; changes time for filing claims; changes grounds for extension of time to file claims; deletes procedural requirements concerning presentation of claims; provides requirement for any action brought upon an untimely claim, etc. Amends Chs. 731, 733, 734, 735. Effective Date: 07/05/89 except as otherwise provided.
