I. SUMMARY:

A. Present Situation:

Section 265.26, F.S., 1988 Supp., designates the John and Mable Ringling Museum of Art as the official art museum of the state, and provides for the management of the museum by a board of trustees. The museum was donated to the state in 1936. Its art collection is the largest collection of 17th and 18th century baroque paintings in the United States. The statutory purpose of the museum is to acquire and preserve objects of art, to provide museum services to communities throughout the state, and to engage in national and international programs to enhance the cultural resources of Florida. The museum consists of an art collection, valued in excess of \$200 million, and the grounds, valued at approximately \$15 million.

The Board of Trustees of the John and Mable Ringling Museum of Art is assigned to the Department of State; however, as specified by law, the board has "complete jurisdiction over the management of the museum . . ." The board of trustees consists of nine members who are appointed by the Governor and confirmed by the Senate, to serve for staggered 4-year terms. Four of the members must be residents of Sarasota County or Manatee County, five must be from five different counties of the state, and all of the members must have been residents and citizens of the state for at least 10 years. The members of the board are not compensated but are entitled to per diem and travel expenses incurred in fulfilling their official duties. The board employs a full-time staff of 99 employees, whose salaries are funded by state appropriation.

The Board of Trustees of the John and Mable Ringling Museum of Art is a state entity, and therefore is generally subject to the state procedures and regulations pertaining to state agencies. The board is exempt from the competitive bidding requirements of s. 287.062, F.S., for the restoration or purchase of art objects, as well as the surplus property provisions of ch. 273, F.S., for the sale or trade of any object of art which has been acquired since 1936.

In 1977, the Legislature granted the John and Mable Ringling Museum of Art the authority to create a direct-support organization. The organization, as specified in s. 265.261, F.S., 1988 Supp., is a corporation not for profit incorporated under ch. 617, F.S., organized and operated to raise funds, submit requests and receive grants, hold, invest, and administer property, and to make expenditures for the benefit of the museum. The direct-support organization must be approved by the board of trustees to be operating on behalf of the museum, and may be authorized to use property, facilities, and personal services of the board, which include both personnel and payroll processing.

The direct-support organization is required to submit annually an audit report conducted by an independent certified public accountant to the board of trustees and to the Auditor General. Other than the audit report, all records of the direct-support organization are exempt from provisions requiring public access to records under ch. 119, F.S., the Public Records Law. Unlike the board of trustees, the direct-support organization is not subject to laws and regulations which generally govern state agencies, such as those which prescribe budget processes, personnel policies, and state audits.

Section 265.26, F.S., 1988 Supp., specifies that the funds held by the direct-support organization are to be kept in a separate trust fund. Such funds do not include those received from admission or rental fees, or funds received from museum programs. A trust agreement must provide that funds held in trust by the direct-support organization revert to the board in the event the agreement is terminated. The direct-support organization must submit its annual budget to the board of trustees for approval.

The direct-support organization of the museum is the John and Mable Ringling Museum of Art Inc. Although not required by law, in accordance with an annual agreement, the Board of Trustees of the John and Mable Ringling Museum of Art serves as the governing board of the direct-support organization.

B. Effect of Proposed Changes:

Section 265.26, F.S., 1988 Supp., would be amended to expand the membership of the Board of Trustees of the John and Mable Ringling Museum of Art to eleven members, rather than the current nine members. Five members, rather than the current four members, would be required to be residents of Sarasota County or Manatee County, and at least two members would be mandated to be from each of those counties. Six members, rather than the current five members, would be required to represent six different counties in the state, selected on a geographical basis. The requirement that members be residents of the state would be reduced from a 10-year residency requirement to a 3-year residency requirement. All appointments would continue to be made by the Governor and confirmed by the Senate.

The board of trustees would be directed to appoint a council to advise and assist the board of trustees in developing nonstate support, in the form of private contributions, and grants from private foundations, corporations, and federal agencies. 'council would be composed of from five to nine members who would serve for 4-year staggered terms. The board of trustees would set policies for the operation and organization of the council. All funds raised through the activities of the council would be deposited with the direct-support organization for the exclusive benefit of the museum and its programs.

B. Government:

It is estimated that minimal costs associated with the travel expenses and per diem of the two additional members of the board of trustees would be incurred.

III. COMMENTS:

The public records exemption currently provided to the directsupport organization in s. 265.26, F.S., 1988 Supp., was reviewed

by the Committee on Governmental Operations pursuant to the Open Government Sunset Review Act. The language in the bill which pertains to exempting certain records of the direct-support organization from the public access requirements of ch. 119, F.S., is identical to the language contained in SB 278, which resulted from the committee's review.

The findings of a review by the Committee on Governmental Operations indicate that the direct-support organization is subject to the sunshine provisions contained in ch. 286.011, F.S., the Public Meetings Law. Thus, the advisory council which would be established in this bill would be required to conduct its activities in the sunshine.

STATEMENT OF SUBSTANTIAL CHANGES CONTAINED IN COMMITTEE SUBSTITUTE FOR Senate Bill 654

Deletes provisions directing the board of trustees to appoint an advisory board of five members to advise on matters pertaining to the direct-support organization. Removes requirements and duties pertaining to the advisory board.

Directs the board of trustees to appoint a council of from five to nine members to assist the board in developing nonstate support. Requires all monies raised through the activities of the council to be deposited with the direct-support organization and used exclusively for the museum and its programs.

Reorganizes certain provisions relating to the direct-support organization.
