I. SUMMARY:

A. Present Situation:

All motor vehicles operated on the roads of Florida and owned by Florida residents must be registered pursuant to chapter 320, F.S., and display a license tag issued pursuant to that chapter. Vehicles owned by nonresidents must be registered pursuant to the laws of their home state or country. Persons employed in Florida or engaged in any trade, profession, or occupation in this state, or persons whose children are enrolled in Florida public schools are considered residents. Nonresident full time students are exempted from registering their vehicle for the duration on their enrollment.

Section 320.08, F.S., contains the various classes of motor vehicles and their respective license taxes. Subsection (2) taxes private automobiles, subsection (3) taxes trucks weighing not more than 5,000 pounds, subsection (6) taxes motor vehicles for hire, paragraph (9)(c) taxes motor homes, and paragraph (9)(d) taxes truck campers.

B. Effect of Proposed Changes:

The bill imposes a \$30 registration fee on all vehicles representing net additions to the stock in Florida. The fee applies to private autos, light trucks, motor vehicles for hire, motor homes and truck campers. The fee is charged on initial registrations in Florida where there is no transfer of registration from another motor vehicle. A refund is provided for those who might purchase a car before selling their old one, as long as the old car is disposed of in less than three months.

The bill provides various exemptions from this fee. These include transfers of title between co-owners, transfers of ownership by operation of law, including inheritance, foreclosure and bankruptcy, transfers of ownership between immediate family members, registration of vehicles by nonresident members of the armed forces stationed in Florida, governmentally owned vehicles, and farm vehicles not principally operated on the roads.

The bill requires that license plates issued for vehicles taxed under s. 320.08(6), F.S. be imprinted with the word "Florida" at the top and the word "Lease" at the bottom. The bill also provides that the owner of a motor vehicle taxed under s. 320.08(6)(a) may register such a vehicle for any 6-month period upon payment of a fee of \$2.50 for each such period; provided, notwithstanding any other provision of law.

The bill provides for a surcharge of 10 cents per day or any part of a day imposed upon the lease or rental of a motor

vehicle licensed for hire and designed to carry less than nine passengers regardless of whether such motor vehicle is licensed in Florida. The surcharge applies to only the first 30 days of the term of any lease or rental. The surcharge is taxable under s. 212.05

The bill authorizes the Department of Highway Safety and Motor Vehicles to:

--create 50 additional positions within the Highway Patrol which, along with current resources, shall be used to establish 35 full-time drug interdiction units consisting of two officers each and canine support solely for the purpose of drug crime surveillance and enforcement.

--provide a \$300 a month competitive pay adjustment for Highway Patrol officers, plus an additional \$50 a month for officers in Region One (South Florida) beginning November 1, 1989.

--provide an equity pay adjustment for Highway Patrol officers beginning November 1, 1989.

--provide a \$473,000 training program for all Highway Patrol officers in drug interdiction techniques and drug crime enforcement.

The bill appropriates from the Law Enforcement Trust Fund of the Department of Highway Safety and Motor Vehicles \$2.9 million to the Department of Corrections to pay for costs associated with this act.

The bill provides for a minimum term of imprisonment of 3 calendar years with no eligibility for parole or gain time during this period for specified violations of controlled substance laws. Additionally, violations of certain other controlled substance laws will require a sentence of a \$500 fine and service of 100 hours of public service in addition to any other penalty prescribed by law.

II. ECONOMIC IMPACT AND FISCAL NOTE:

A. Public:

Motor vehicles which represent additions to the stock in Florida would be required to pay an additional \$30 registration fee. This fee would primarily be paid by new residents moving into the state. Existing residents would also pay the fee to the extent that they acquire additional vehicles.

Renters and lessees of private autos, light trucks and motor homes, would pay an additional 10 cents per day on the first 30 days of their leases.

B. Government:

The \$30 registration fee would raise approximately \$14.2 million on an annualized basis and the 10 cents per day fee on rental cars would raise approximately \$2.5 million on an annualized basis, for a total of \$16.7 million. In 1989-90, the revenues raised from these two sources for the Law Enforcement Trust Fund during the 9 months they are in effect, would be \$11.3 million.

The bill provides the following 1989-90 appropriations from the Law Enforcement Trust Fund:

I. SUMMARY:

A. PRESENT SITUATION:

All motor vehicles operated on the roads of Florida and owned by Florida residents must be registered pursuant to chapter 320, F.S., and display a license tag issued pursuant to that chapter. Vehicles owned by nonresidents must be registered pursuant to the laws of their home state or country. Persons employed in Florida or engaged in any trade, profession, or occupation in this state, or persons whose children are enrolled in Florida public schools are considered residents. Nonresident full time students are exempted from registering their vehicle for the duration of their enrollment.

Section 320.08, F.S., contains the various classes of motor vehicles and their respective license taxes. Subsection (2) taxes private automobile, subsection (3) taxes trucks weighing not more than 5,000 pounds, subsection (6) taxes motor vehicles for hire, paragraph (9)(c) taxes motor homes, and paragraph (9)(d) taxes truck campers.

In FY 1989-90, the revenues raised from the \$30 per day registration fee and the 10 cents per day fee on rental cars will total an estimated \$11.3 million.

On a recurring basis, the \$30 registration fee will raise approximately \$14.2 million and the 10 cents per day rental car fee will raise approximately \$2.5 million.
