H 1810 GENERAL BILL/CS/CS/2ND ENG by Rules & Calendar; Rules & Calendar; Select Committee on STOP Crime; Langton; Jamerson; Simon; Wise and others (Compare CS/H 312, CS/H 951, H 1289, S 892)

STOP Crime Act; creates Serious Targeted Offender Program; requires Corrections Dept. to contract for provision of assessment & treatment providers & services for adult & youthful targeted offenders & for evaluation of said program; provides components of adult & youthful programs, including removal of offenders from such programs; provides for additional community-based facilities, etc. Amends F.S. Effective Date: 07/01/90 except as otherwise provided; s. 1 on 01/01/90.
