**S 10-B GENERAL BILL/2ND ENG by Forman (Compare CS/H 625, CS/1ST ENG/H 1199, 1ST ENG/H 1804, H 13-B, S 754, CS/1ST ENG/S 1178)**

**Taxation; extends repeal date for provisions which authorize certain air carriers to pay aviation fuel tax at specified rate on retail price of fuel; provides limitation on ratio used to determine application of sales tax to purchases by certain air carriers; limits to certain facilities exemption from transient rentals tax for entire facility; authorizes D.O.R. to contract with C.P.A.'s to audit certain persons, etc. Amends Chs. 206, 212, 213. Effective Date: 10/01/89 except as otherwise provided.**

06/20/89 SENATE Filed; Introduction allowed; Introduced, referred to Finance, Taxation and Claims; Immediately withdrawn from Finance, Taxation and Claims; Passed as amended; YEAS 31 NAYS 3 -SJ 8

06/20/89 HOUSE In Messages; Introduction allowed -HJ 21; Received, placed on Calendar; Read second time; Amendments adopted; Read third time; Passed as amended; YEAS 105 NAYS 6 -HJ 22
