

MISCELLANEOUS LOCAL GOVERNMENT

CS/SB 54 — Local Government Minimum Wage

by Comprehensive Planning Committee and Senators Constantine, Fasano, Cowin, Wise, and Lynn

This committee substitute prohibits the political subdivisions of the state from requiring employers to pay a minimum wage other than a federal minimum wage, or from requiring employers to apply a federal minimum wage to wages that are exempt under federal law. However, political subdivisions may establish a minimum wage for their employees, for employees of contractors and subcontractors under contract with the political subdivision, and for employees of employers receiving direct tax abatements or subsidies from the political subdivision.

This committee substitute creates an unnumbered section of the Florida Statutes.

If approved by the Governor, these provisions take effect upon becoming law *Vote. Senate 22-13, House 84-32*

SB 732 — Miami River Commission

by Senator Villalobos

This bill removes language that would sunset the Miami River Commission on July 1, 2003 and, therefore, effectively establishes a permanent commission.

This bill repeals section 7 of chapter 98-402, Laws of Florida.

If approved by the Governor, these provisions take effect upon becoming law *Vote*: Senate 39-0. House 117-0

HB 1721 — Subdivision Property

by Rep. Bilirakis and others (CS/SB 1824 by Comprehensive Planning Committee and Senators Sebesta, Crist, and Fasano)

This bill increases the tax deed application fee from \$15 to \$75, requires that before property is sold under an outstanding tax certificate on land that is either submerged land or common elements in a subdivision, each owner of property contiguous to the property subject to sale must be notified, requires that a county notify each owner of such property within 90 days after property is placed on the list of lands available for taxes if the county holds the tax certificate and does not purchase the property; and requires that the value of taxes and non-ad valorem assessments against common elements of a subdivision be prorated by the property appraiser and included within the value of the lots within the subdivision.

PENELAS CRITICAL OF NEW PAY LAW

Over the objections of Miami-Dade Mayor Alex Penelas, Gov. Jeb Bush signed into law Wednesday a bill that critics fear could cut pay in half for up to 4,000 workers at Miami International Airport.

Bush signed the bill that prevents cities and counties in some circumstances from forcing local companies to pay wages higher than the federal minimum

The law doesn't affect rules in Miami-Dade and Broward counties and Miami Beach requiring their own government employees be paid higher than the federal minimum

But Penelas and others fear companies doing work at the airport could use the law to drop employees' wages. The companies have been operating under a county ordinance requiring that airport workers, particularly those with security-sensitive positions, make twice the federal minimum wage, now \$5.15 an hour. About 4,000 workers - 2,000 in security-sensitive jobs - are covered by the county rule.

Bush added in a letter accompanying his signature that he shares Penelas' fears about the airport workers, and called company heads to warn them not to use the law to cut airport workers' pay.

"I am signing this legislation with the express expectation that it will not be used to reduce the wages of any current employee. "Bush said in the letter." I expect employers to honor the law and to honor their commitments to these individuals on both legal and moral grounds. This administration will use its power and resources to ensure that they do."

The announcement took some workers at Miami International Airport's Swissport USA by surprise. Ramp duty manager Claudio Boyett feared for the 500 or so passenger service and cargo workers the company employs there.

He said when the original Miami-Dade County ordinance passed years ago, most employees' paychecks rose, so he expects them to fall now.

"Wow, it's going to affect everyone," said Boyett, 43, a father of three who earns \$16.50 an hour "Most people are used to their earnings, now they're most likely going to have to look for other jobs."

Swissport executives could not be reached for comment late Wednesday

Backers of the law said companies shouldn't have to pay different minimum wages in different cities or counties

Bush said he'll seek legislation to make it clear that security-sensitive jobs should be exempt from the law, but Penelas said in a telephone interview he was disappointed

"I understand he's going to make an effort to fix the glitch and urge private permit holders not to lower salaries but this is still going to cause a terrible amount of instability in thousands of households in Miami-Dade County," said Penelas, a Democrat who is running for U.S. Senate and who last week led a rally at the airport calling for Bush to veto the bill. "I appreciate him saying this, but there are no assurances this will happen and we could be looking at tremendous turnover in critical areas as wages get cut."

Broward County attorney Ed Dion said the law will not affect Broward's living wage ordinance, in effect Oct. 1

"We wrote in a certain language so that a bill like this would not affect it," he said. "Our ordinance can still be enforced." The ordinance dictates that county employees and employees with businesses that contract with Broward for \$100,000 or more must receive at least \$9.57 an hour. It does not apply to workplaces that do not do business with the county.

"It's up to those businesses to decide on their own what they pay their employees," said Dion

Today, I hereby transmit to you, with my signature, Committee Substitute for Senate Bill 54, an Act relating to Local Government/Minimum (Living) Wage, passed by the Florida Legislature on May 2, 2003. I have signed this bill because it is an important measure in making sure that Florida's economy remains competitive and continues to foster job growth for Florida's 16 million residents.

Numerous surveys and studies by independent economists confirm that so-called "living wage" ordinances requiring private employers to pay a certain amount significantly above the federally required minimum wage create higher unemployment and reduce economic growth. Far from helping the most unskilled workers increase their standard of living, "living wage" ordinances generally lead to layoffs, increased costs to businesses and higher prices for consumers. Moreover, the potential for many different "living wage" ordinances that may impose varying requirements on employers that do business across our state threatens to undermine the stability and economic predictability that are important to those who are attracted to doing business in our state. Such destabilization would drive employers from Florida, resulting in the loss of jobs across all sectors of our economy. CS/SB 54 ensures that Florida has a uniform minimum wage, the federal minimum wage, across the entire state, except under very limited circumstances. Under CS/SB 54, cities, counties and private employers will be free to establish their own wage rates for employees, based upon the market and the skills of the individuals -- core principles of our system.

CS/SB 54 strikes an appropriate balance between respecting the rights of private employers to set their employees' pay based on qualifications and the valid interests of local governments in distributing the benefits of their public spending by requiring that those who voluntarily contract with or lease from local



government or otherwise receive special incentives agree to pay their employees wages commensurate with the costs of living in the communities that they serve. In addition, government employers still have the right to set higher wages for their employees as they see fit.

Florida is a national leader in promoting economic growth and increased job opportunities. Our low tax environment and flexible workforce are two of the many reasons why businesses from all over the world invest in Florida. These investments, in turn, create a climate of economic opportunity for all Floridians, who benefit directly from the creation of the jobs and related business activities resulting from such investment.

Florida's job market gained 92,800 jobs over the past year. It is the only state in the nation that has steadily increased the number of jobs over the past 13 months. Florida's unemployment rate has been below the national unemployment rate for 14 consecutive months. This sustained job growth continues to demonstrate that Florida's businesses are growing. We continue to create more jobs for Floridians and we are doing it at a faster rate than the ten most populous states. This is a record of which we can be proud.

Responding to Concerns

Despite the sound economic policy promoted by CS/SB 54, some have raised concerns that application of CS/SB 54 will result in the reduction of the wages of approximately 2,700 workers employed by some service providers at the Miami International Airport. These service providers hold permits from Miami-Dade County to operate at the airport but otherwise do not contract with or lease from Miami-Dade County. In September 2002, the Miami-Dade County Commission expanded the County's "living wage" ordinance to these employers out of concern that lower wages for workers engaged in fueling planes, providing catering, handling baggage and cleaning aircraft led to reduced security due to the high turn-over in these jobs, which require a security clearance.

I, too, am concerned about the potential effect that the prohibition may have had on these workers. That is not the purpose or intent of this bill. It is intended to apply prospectively only and not to nullify Miami-Dade County's or any other existing ordinance.

I am signing this Legislation with the express expectation that it will not be used to reduce the wages of any current employee who is employed under a salary arrangement agreed in reliance on an existing ordinance.

I expect employers to honor the law and to honor their commitments to these addividuals or both legal and meral grounds. This administration will use its power and resources to ensure that they do.

I have placed phone calls to the CEO's of the largest such employers identified by Miami-Dade County, urging them not to use this legislation as an excuse to reduce their employees' wages. Good business would dictate that once you hire an employee at a certain wage you do not lower their salary arbitrarily. I also would expect these employers to be sensitive to the security concerns that led to the expansion of the Miami-Dage County ordinance to airport permit holders.

Furthermore, in order to eliminate any doubt as to the applicability of CS/SB 54 to the employees of service providers at security sensitive facilities owned and operated by local governments. I intend to propose Legislation for the purpose of ciarifying the bill's language. I believe that it is in Flonda's best interest that local governments be able to use a variety of means for improving the stability and the quality of the workforce servicing the most sensitive facilities in the state, such as airports. This should include requirements related to compensation.

For the reasons stated above, I do hereby sign Committee Substitute for Senate Bill 54.
